



#### **Resolution 328**

1. The Board granted leave of absence to Captain S. H. Sarma, Sarvashri V. Balagangadharan, Ratanshi Panchan and A. A. Kochunny who had expressed their inability to attend the meeting.

2. Read, confirmed and recorded the minutes of proceedings of Meeting No. 11 of 1967-68 held on 17th November, 1967 subject to para 4 of Resolution No. 311 (para 45 of the minutes) being recast as follows: follows:



  - Provided that interest beyond a period of one year may be authorised by the Financial Adviser and Chief Accounts Officer/Head Adviser and Ghier Accounts Omcer/Head of Accounts Department after he has per-sonally satisfied himself that the delay in payment was occasioned by circumstances beyond the control of the subscriber and that administrative delays involved in the matter have been fully investigated and extion taken action taken.
  - Provided further that the benefits under the immediately preceding proviso herein shall immediately preceding proviso herein shan be available only for the period during which the Ministry of Finance Office Memoran-dum N. F-49 (1)-EV/60, dated 11th March, 1960 is in force or is extended by the Central Government from time to time and that such benefits shall cease to be available on the expiry of the said period or extended period of the said Memorandum or on the withdrawal of the said O.M. by the Central Government", subject to the approval of the Central Government under section 124 of the Major Port Trusts Act."

#### **Resolution 351**

47. Read Chairman's note, dated 28th November, 1967, regarding creation of additional posts in the supervisory cadre in the Traffic Department.

# AGENDA ITEM No.27

Adaptation of amendments and clarifications issued by the Central Government to Fundamental Rules, Supplementary Rules Civil Service Regulations, General Financial Rules, Treasury Rules etc. mantioned as the existing Rules in the Major Port Trust (Adaptation of Rules) Regulations, 19641

Reference is invited to Reso No.512 of Meeting No.17 of the Board of Trustees held on Friday, the 16th of July, 1965, on the above subject - copy reproduced below:-

"15. Resolved, with reference to the Chairman's note dated 6-7-1965 to approve of the proposal to give effect to the amendments and clarifications issued by the Central Government to Fundamental Rules, Supplementary Rules, Civil Service Regulations, General Financial Rules and Treasury Rules which have already been made applicable to the Trust, without reference to the Board, provided they are not inconsistent with the provisions of the Major Port Trusts Act or Regulations issued thereunder or unless the Port Trust decides otherwise".

On the same question, which had been referred to Government by the Vizag Port Trust, the Government stated, after obtaining the opinion of the Ministry of Law, that the proposal to adopt the Central Government Rules goes against the mandatory provision of Section 124 of the Major Port Trusts Act, according to which the implication of each amendment which may be made by the Central Government to the various rules, which continue to apply to the Port employees, will have to be separately considered before the amendment can be applied to the Port Trust employees.

2. The matter was then placed before the Inter Port Consultation's and according to its decision dated 14-10-1966 as given below, the matter was taken up again with the Government.

"It was felt that the Cochin, Kandla and Vishakhapatnam Port Trusts should take up the matter further with Government and cite, if necessary, the instance of the Calcutta Port Commissioners who had taken Resolutions adopting the F.Rs. S.Rs. and certain other Government Rules with provision that amendments to such Rules, as might be made by the Central Government from time to time, would also automatically apply in respect of their employees."

3. Government considered the matter further in consultation with the Ministry of Law and have advised that the purpose aimed at can be achieved by amending Regulation 4 of the Major Port Trust (Adaptation of Rules) Regulations 1964. A copy of the amendment to the Adaptation Regulation forwarded by the Government is attached.

4. Accordingly, as advised by the Min stry, it is proposed to substitute the existing Regulation 4 of the Major Port Frusts Act (Adaptation of Rules) Regulations, 1964 as follows:-

# Notification

In exercise of the powers conferred by Section 28 and 123 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees constituted for the Cochin Port hereby makes the following regulations to amend the Major Port Trusts (Adaptation of Rules) Regulations, in so far as they apply to the Port Trust of Cochin, namely:-

1. These Regulations may be called the Major Port Trusts (Adaptation of Rules) Amendment Regulations, 1967.

2. In the Major Port Trusts (Adaptation of Rules) Regulations, 1964, for regulation 4, the following regulations shall be substituted, namely:-

"4. Existing rules to continue:- Existing Rules and orders and subsequent amendments thereto made on or after the date of coming into force of the Major Port Trusts (Adaptation of Rules) Amendment Regulations, 1967, relating to the following matters shall, to the extent they are not inconsistent with the provisions of the Act or any regulations made thereunder, continue in force namely:-

i) matters specified in clause (b), Clause (c) and Clause (e) of Section 28 of the Act; and

ii) matters specified in clause (b) and clause (e) to (n) of Section 123 of the Act.

Provided that any amendment aforesaid to the existing rules and orders not advantageous to an employee shall not be made applicable to such employees unless the Board obtains the previous sanction of the Central Government."

5. Board's approval to the proposal is requested for further action as contemplated in the Major Port Trusts Act, 1963.
