

By this time, some other officers in any Major Ports in the feeder grade might have acquired the eligibility for selection to the post on absorption basis.
17.	Recommendations of the SSC	The Committee after considering that the post of Superintending Engineer (M) is a Senior Class-I post which is to be filled up by selection method from among a sufficient number of competitive candidates and, that, presently only one eligible candidate is available for selection to the post, did not recommend the candidate for selection to the post of Superintending Engineer (M) on absorption basis.
