With reference to the above, the information is given below.

- SI. No. 1 The Cochin Port Service attended first coal fire after 04.06.2018 on 06.09.2018 at 0845 Hrs in response to a call from Ernakulam Wharf Superintendent.
- SI. No. 2 ii & iii The Cochin Port Fire Service attended 191 calls with total 270 trips from the period 06.09.2018 to 16.03.2019 to control the smoke and to douse the flame due to spontaneous combustion.
- Sl. No. 3 The Cochin Port Fire Service received total 191 calls from CISF Control Room, Ernakulam Wharf Superintendents, Dury Port Staff and adjacent private company's staff.
- SI. No. 4 Each incidents of Fire lasted One to Three hours (approx.) depending up Number of times fire tender sent, location & intensity of Fire.
- SI. No. 5 1 to 3 times Fire tenders were put into service for each incidence reported depending on the gravity of smoke & Fire
