The matter was pending bern, one Central Government. It appears that the fifth respondent also moved this court and this court directed the Union of India to take a final decision on the proposed amendment forwarded by the first respondent. The final amendment was approved by the Union of India and notified in the gazette on 8.3.2002 and the amendment was to take effect from the date of publication of the Notification. While so, in the meantime the petitioner was promoted on adhoc basis to the post on 28.2.2003. When the Rules came, she was reverted by Ext.P14 order and by Ext.P15 order dated 13.5.2002, the fifth respondent was promoted. The petitioner challenges Exts.P14 and 15 orders.

- 2. The main ground of attack against the reversion of the petitioner and the promotion of the 5th respondent is that when the vacancy arose on 1.12.2000, the petitioner alone was the qualified candidate. Relying on the principle that the claim has to be considered with reference to the date of occurrence of vacancy, the petitioner is entitled to be promoted with effect from 1.12.2000, it is contended.

4. It is not in dispute that the claim for respondent was promoted. promotion has to be considered with reference to the conditions obtained on the date of occurrence of vacancies. But in appropriate cases, the Government or the employer may take a conscious decision not to fill up the vacancies pending emendment to the Bules. In that event, vacancy need be filled only after the amendment and in the light of the amended Rules The first respondent can claim that there is a conscious decision if only there is a resolution by the Board of Trustees followed by an order issued by the brought to the notice of the affected persons.
