ELIGIBLE CANDIDATES OF MAJOR PORT TRUSTS**

- 1) The post of Deputy Mechanical Engineer (Electrical/Electronics & Communication) will fall vacant with effect from 01.12.2018. Accordingly, Applications are invited for filling up the post of Dy.Chief Mechanical Engineer(Ele./E&C) in the Scale of Pay of Rs.32900-58000 (Pre-revised Rs.16000-20800) in Cochin Port Trust by absorption through composite method.
- 2) As per Recruitment Rules for absorption through composite method, Officers holding analogous posts or the posts of Superintending Engineer and equivalent posts in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. in the Scale of pay of Rs.13000-18250 (Revised Rs.24900-50500) with three year regular service in the grade in the Electrical /Electronics & Communication discipline in a Major Port Trust or Superintending Engineer and equivalent post in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. with two years regular service in the grade and a combined regular service of seven years in the Scales of Pay of Rs.10750-16750 (Revised Rs.20600-46500) and Rs.13000-18250 (Revised Rs.24900-50500) in the Electrical /Electronics & Communication discipline in a Major Port Trust will be eligible.
