- 4. The applicants should have at least 3 years service left as on 01.05.2020 for retirement on superannuation in the parent organization for deputation posting.
- 5. The applications received through proper channel only will be considered. The applications received after the last date or without ACRs or otherwise incomplete will not be considered.
