#### 1. NOTICE INVITING TENDER

1. Electronic Tenders (e-tenders) in Single Stage Two Cover bidding procedure [Technical Bid and Financial Bid], are invited by The Chief Mechanical Engineer, Cochin Port Trust, Willingdon Island, Cochin-682 009 from reputed Contractors meeting the Minimum Eligibility Criteria specified below for the work of 'Painting of Marine Loading Arms, Pipelines, Monitor Towers and Structures at Cochin Oil Terminal"

#### 2. Minimum Eligibility Criteria:

#### a) Experience

The tenderers should have experience of having successfully completed similar works during the last 7 (seven) years ending 29<sup>th</sup> February, 2020 should be either of the following:

- i) Three similar completed works each costing not less than **Rs.15,86,000/-**(OR)

5. This work essentially comprises of surface preparation and painting of Marine Loading Arms, Fire Water Pipelines, Foam Pipelines, Crude Oil and other Product Lines, Fire Monitor Towers and Base Monitors, Foam Tanks, Cable



Trays, Hand Rails, Lamp Posts etc. installed at Cochin Oil Terminal (COT) situated in the Ernakulam Channel at Willingdon Island, as per the Scope Work indicated in the Tender Document. As the Cochin Oil Terminal is situated in the Ernakulam Channel, there is no road access to reach at COT. The means of access to COT is by Boat either from Ernakulam Boat Jetty or from Willingdon Island. The Contractor shall arrange proper means of transport of his own, for transporting his materials, equipments & fixtures, labour etc. to the worksite to execute the contract.

- 6. - 7. Bid document will also be available in Cochin Port website (www.cochinport.gov.in) as well as Central Public Procurement (CPP) Portal, which can be downloaded. The cost of bid document shall be furnished in the form of Demand Draft/ Banker's Cheque drawn in favour of FA & CAO, Cochin Port Trust, along with the submission of bid.

Any shortfall in submissions of the said Addenda/Amendments/Errata/Replies to the queries of bidders etc., duly signed along with the downloaded documents while submitting the bid will not be considered. #### 2. INSTRUCTIONS TO TENDERERS

#### 1. Introduction

1.1 Sealed tenders in two-cover system are invited from eligible Tenderers for the work of 'Painting of Marine Loading Arms, Pipelines, Monitor Towers and Structures at Cochin Oil Terminal" as per the scope of work given in General Description of Work, Section III of this tender document.

#### 2. General Instructions

- 2.1 The Work is to be executed as described in the Bid document and in particular in the General Description of Work, Special Conditions of Contract, Bill of Quantities in general includes, but is not limited to, supplying all materials including consumables and equipment necessary to execute the Work as described in the Bid Document.
- 2.2 Before submitting the bid, the bidder shall examine carefully all conditions of contract, specifications, drawings etc. supplied herewith. The bidders shall inspect the site of Work with prior appointment with the Engineer-in-Charge of the Work to get himself acquainted with the site conditions and to assess and satisfy himself of the difficulties and constraints which may be involved in executing the Work in the location. It will be deemed that prior to the submission of tender, the tenderer has visited the site and has satisfied himself as to the nature and location of the Work, general and local conditions, particularly those pertaining to transportation, handling and availability and storage of materials, availability of labour, weather conditions, tidal variations at site, working conditions etc. and that the tenderer has estimated his cost accordingly and the Port Trust will be in no way responsible for the lack of such knowledge and also consequences thereof to the tenderer. Failure to visit the site will in no way relieve the successful bidder of any of the obligations in performing the Work in accordance with this Bid Document including addenda/corrigenda, within the quoted price.
- 2.3 A bidder shall be deemed to have full knowledge of all documents, site conditions etc. whether he has inspected them or not. The submission of a bid by the bidder implies that he has read the Notice and Conditions of Contract and has made himself aware of the scope and specifications and other factors bearing on the bid and that they are binding on him.
- 2.4 The bidders may please note that the EMPLOYER will not entertain any correspondence or query on the status of the offers received against this Bid. Bidders are also requested not to depute any of their personnel or agents to visit the Employer's offices for making such enquiries till finalisation of the bid. Should the EMPLOYER find it necessary to seek any clarification, technical or otherwise, the concerned bidder will be duly contacted by the EMPLOYER.



- 2.5 Canvassing in any form by the bidder or by any other agency acting on behalf of the bidder after submission of the bid may disqualify the said bidder. The Employer's decision in this regard shall be final and binding on the bidder.
- 2.6 The EMPLOYER will not be liable for any financial obligation in connection with the Work until such time the EMPLOYER has communicated to the successful bidder in writing his decision to entrust the Work (covered by the bid document issued to him).
- 2.7 Telex/E-mail offers will not be considered. Bidders should prepare their bid themselves and submit it "online". Bids submitted by agents will not be recognized.
- 2.8 Bids received after the due date and time and any change in bid after the specified date will be rejected. EMPLOYER will not be responsible for the loss of the bid document or for the delay in postal transit.
- 2.9 In case of an unscheduled holiday on the prescribed closing/opening day of the bid, the next working day will be treated as the scheduled prescribed day of closing/opening of the bid.
- 2.10 While evaluating the document, regard would be paid to National defense and security considerations, at the discretion of the Cochin Port Trust. Bid received from any bidder may be summarily rejected on National security consideration without any intimation thereof to the bidder.
- 2.11 If there are varying or conflicting provisions made in any document forming part of the contract, the Chief Mechanical Engineer, Cochin Port Trust, Cochin 682009 shall be the deciding authority with regard to the intention of the document, which shall be binding on the Bidder.
- 2.12 Any error in description and any omissions there from shall not vitiate the contract or release the Contractors from the execution of whole Work or any part of the works comprised therein, according to drawing and specifications or from any of his obligations under the contract.
- 2.13 All the Bank Guarantees (BGs) to be furnished except for EMD by the Contractors in connection with the tender shall be sent to the Chief Mechanical Engineer, Cochin Port Trust directly by the issuing bank under registered post with AD. The Contractor shall take the responsibility of sending BGs directly to the Port Trust by the issuing bank.
- 2.14 The Contractor shall comply with all the provisions of the Indian Workmen's Compensations Act, Provident Fund Regulations, Employees Provident Fund and ESI Act etc. as amended from time to time and rules framed there under and other laws affecting the contract labour that may be brought in to force from time to time.
- 2.15 The Contractor shall be registered under EPF and ESI Act and the employees employed under them shall be covered in the EPF and ESI scheme. Work Order shall be issued only to the Contractors who are registered under EPF organisation and ESI Corporation. The Contractors shall regularly remit the employer and employee contribution to the



authorities. If not, the Department would remit the same and the amount so remitted shall be deducted from the part/final bill of Contractor.

- 2.16 The Contractor shall be registered under GST and shall furnish documentary evidence in support of valid GST registration.
- 2.17 Bidders who are registered with National Small Industries Corporation (NSIC), Govt. of India and Enterprises under "Single Point Registration Scheme" of Ministry of MSME for similar nature of works shall be eligible for issue of tender document free of cost and exemption from payment of Earnest Money Deposit. They are required to submit the duly notarized documentary proof of such registration, which should be valid at the time of bidding, along with the offer uploaded in the e-tender Portal, for claiming the available exemptions. If Registration Certificate does not pertaining to the Category of "Similar Works" mentioned in this tender document, the tender will be rejected. The exemption is allowed as above only for the EMD and Cost of Tender Fee charges and not for any other charges or Deposits.

#### 3. Invitation for Bids:

The Invitation for Bids is open to all eligible bidders meeting the Minimum Eligibility Criteria.

#### 4. Downloading of Tender Documents:

Tender documents can be downloaded from the e-Tendering portal www.tenderwizard.com/COPT on the dates specified in NIT by making online requisition. Tender document can also be downloaded from Cochin Port website <a href="www.cochinport.gov.in">www.cochinport.gov.in</a> or Central Public Procurement (CPP) Portal. Demand Draft / Banker's Cheque for cost of tender document drawn in favour of the Financial Adviser & Chief Accounts Officer(FA &CAO), CoPT from any Commercial Bank having its branch at Kochi shall be submitted at the time of submission of bids and scanned copy of the same shall be attached with the e-tender.

In case of tender document being downloaded from the website, at the time of uploading, the tenderer shall give an undertaking that no changes have been made in the document. If any such mention is made, the tender will become invalid and shall become liable for rejection.

#### 14.2 Currencies of Bid and Payment:

The unit rates and the prices in the Schedule II of this document are in Indian National Rupees (INR).

#### 15. Bid Validity:

15.1 Bids shall remain valid for a period not less than one hundred twenty days (120) after the deadline date for bid submission. A bid valid for a shorter period shall be rejected by the Employer as non-responsive. Should any tenderer withdraw his tender before these periods, or make any modification in the terms and conditions of the tender which are not acceptable to the Cochin Port, the earnest money deposited by the tenderer shall be forfeited.

In exceptional circumstances, prior to expiry of the original time limit, the Employer may request that Bidder may extend the period of validity for an



additional period. The request and bidders response shall be made in writing. A bidder agreeing to the request will not be permitted to modify his bid (ie, the extension shall be unconditional).

#### 16. Bid Security / EMD:

16.1 Each tender should be accompanied by an Earnest Money amounting to Rs.39, 650/- (Rupees Thirty Nine Thousand Six hundred and Fifty only). EMD shall be furnished either through Demand Draft / Banker's Cheque drawn in favour of Financial Adviser & Chief Accounts Officer, Cochin Port Trust payable at Kochi, from any Commercial Bank in India. The Earnest Money Deposit will not carry any interest. Any bid not accompanied by an acceptable Bid Security shall be treated as Non-responsive and shall be rejected by the Employer.

#### 16.2 Forfeiture of Bid Security / EMD

Bid Security / EMD will be forfeited in the following cases:

- (a) If a Bidder withdraws his bid during the period of bid validity.
- (b) The Bidder does not accept the correction of the Bid Price pursuant to any arithmetical errors.
- (c) In case of a successful bidder fails
  - i) to commence the work, within the specified time limit
  - ii) to sign the Agreement or furnish the required Performance Security within the specified time limit

#### 17. No Alternative Proposals by Bidders:

Bidders shall submit offers that comply with the requirements of the bidding documents. Alternatives will not be considered.

#### 18. Format and Signing of Bid:

- 18.1 Tenderer shall prepare one set of his Tender, duly completed and signed, along with other documents mentioned hereinafter. Form of Bid shall be signed by a person or persons duly authorised to sign on behalf of the Bidder with signature duly witnessed and company seal affixed. The Power of Attorney (in original) authorizing the signatory/s of the Tender shall be enclosed. All pages of the bid where entries or amendments have been made, shall be signed by the person or persons signing the Bid.
- 18.2 If the tender is made by an individual it shall be signed by his full name and his address shall be given. In the event of the tender being submitted by a registered partnership firm, it must be signed individually by each partner thereof. In the event of absence of any partner, it must be signed on his behalf by person holding a proper Power-of-Attorney authorising him to do so and to bind the partner in all matters pertaining to the contract including the arbitration clause, such power-of-attorney to be attached with the tender which must disclose that the firm is duly registered under Indian Partnership Act. If the tender is made by a Limited Company it shall be signed by a duly authorised person who shall produce with the tender satisfactory evidence of



the authorisation. In the case of a Limited Company the tender should be accompanied by the Memorandum and Articles of Association of the Company.

#### 19. Bid Submission:

- 19.1 Bid shall be submitted in prescribed form in two parts, **Part I: Technical Bid** and **Part II: Price Bid** through e- tender mode before 15:00 hrs. on 08-04-2020.
- 19.2 Part-I, the **Technical Bid** document, the scanned copies of the documents as detailed in clause 21 below shall be submitted through e-Tendering mode on **www.tenderwizard.com/COPT.**
- 19.3 Part-II, Price Bid (Schedule-II) in the provided format shall be submitted **only through e-tendering mode on <u>www.tenderwizard.com/COPT</u>** before 15.00hrs on 08-04-2020. **In no case shall filled in Price Bid (Schedule II) be submitted in hard copy, as it shall result in rejection of the tender**.
- 19.4 Tenders shall be submitted "**online**" strictly in accordance with the Instructions to Tenderers and Terms & Conditions given in the tender document. The bidders should submit scanned copy of all the required documents such as DD / Pay Order / Banker's Cheque towards the cost of tender and EMD; proof of experience, financial details etc. through the e-tendering portal.
- 19.5 The Bidder shall submit Original (i) DD / Bankers Cheque towards the cost of tender (ii) DD / Pay Order / Bankers Cheque towards EMD, (iii) Power of Attorney, if applicable along with letter of submission in a sealed cover, superscribing thereon the Tender Number, Name of Work, date notified for submission of tender and the name & address of the tenderer, either in person or sent by registered post/ courier to the Chief Mechanical Engineer, Cochin Port Trust, W/Island, Cochin 682009, KERALA, on or before the last date and time of submission of Bids. The above sealed cover containing financial instruments, Power of Attorney, if applicable along with letter of submission brought in person, shall be submitted in Chief Mechanical Engineer's office / put in the designated Tender Box on or before the last date and time of submission of Bids.
- 19.6 Tenders without submitting the original documents towards Cost of Tender document and EMD as above, on or before the last date and time of submission of Bids, will make the tender be liable for rejection.
- 19.7 Hard copy of Part-I, Technical Bid Document and scanned copies of documents as per Clause 20 below except the Financial Bid, which are submitted through e-tendering mode on <a href="www.tenderwizard.com/COPT">www.tenderwizard.com/COPT</a>, shall also be submitted to the Chief Mechanical Engineer, Cochin Port Trust, Willingdon Island, Cochin 682 009, Kerala in a sealed cover superscribing thereon the Tender Number and name of work, date notified for submission of the tender and name of the tenderer on or before the last date and time of submission of Bids. Hard copy of Part-I, Technical Bid Document brought in person, shall be submitted in Chief Mechanical Engineer's office / put in the Tender Box on or before the due date specified above.



#### 20. Information Required in the Bid

- 20.1 **Part I -Technical Bid** shall contain the following:
  - a) Bid Security/ Earnest Money Deposit as described in Clause 16.1 above
  - b) Cost of Tender Document
  - c) Check List as per Schedule I
  - d) Letter of Submission (vide Annexure 1)
  - e) Power of Attorney (in original) in favour of signatory/s to the Tender, duly authenticated by Notary Public. (vide Annexure 2)
  - f) Details of experience as per Annexure 3 and Certificates in proof of experience in similar works as detailed under Clause 12 of Instruction to Tenderers.

#### **Explanatory notes:**

- (1) Original or notary certified copy of completion certificates of each work issued by the owner/ the responsible officers of the owner under whom he has executed such contracts and copy of connected work order shall be attached. The certificate shall invariably contain the following among other things.
  - a) Details of work involved specifying the nature of work

  - c) Date of commencement; and
  - d) Date of completion of the work.

- k) Copies of PAN, GST, EPF and ESI registration
- 1) Documentary proof for NSIC registration, if applicable.
- m) A Declaration to the effect that (vide Annexure 4):
  - i) No conditions are incorporated in the financial bid. In case any conditions are specified in the financial bid, the tender will be rejected summarily without making any further reference to the bidder.
  - ii) We have quoted for all the 14 line items in the Financial Bid.
  - iii) We have not made any payment or illegal gratification to any persons/



- authority connected with the bid process so as to influence the bid process and have not committed any offence under PC Act in connection with the bid.
- iv) We disclose with that we have made / not made payments or propose to be made to any intermediaries (agents) etc in connection with the bid.
- v) We do hereby confirm that no changes have been made in the tender document uploaded by us for the above bid. Port Tender document will be treated as authentic tender and if any discrepancy is noticed at any stage between the Port's tender document and the one submitted by the tenderer, the Port's document shall prevail.
- n) Details of the Party opting for Refund of EMD through e payment system as per Annexure 5.
- o) Bank information for e- Payment system as per Annexure 6.
- 20.2 **Part II : "Price Bid"** shall contain Bill of Quantities- Schedule II shall be duly filled in and fully priced, which shall be submitted only **in e-tendering mode**

#### 21. List of documents to be uploaded for online submission of Technical Bid

- i) Scanned copy of financial instruments towards cost of tender document and EMD / Bid Security.
- ii) Scanned copies of Annexures 1 to 6, duly signed.
- iii) Scanned copy of Form of Bid duly signed.
- iv) Scanned copy of Partnership Deed / Registration Certificate of the Company, as the case may be.
- v) Scanned notarized copies of completion certificates and work orders / agreement of similar works.
- vi) Scanned copies of Audited Financial statements for the last three years.
- vii)Technical Bid document including all addenda/corrigendum and General Conditions of Contract with Amendments in PDF format.

#### 22. Deadline for Submission of the Bids:

E-tenders attaching all documents shall be submitted 'on-line' in the e tender portal strictly in accordance with the terms and conditions of tender document before the time and the day notified in Table 1.2 of NIT.

The Original DD / Pay Order / Bankers Cheque towards the cost of tender and EMD, Power of Attorney along with letter of submission in a sealed cover in original superscribed with the Tender Number, Name of Work, date notified for submission of tender and the Name of the Tenderer, should reach the office of the Chief Mechanical Engineer, Cochin Port Trust, Cochin-9, on or before the time and the day notified in Table 1.2 of NIT.

#### 23. Late Bids

Any Bid received by the Employer after the Bid due date will be returned



unopened to the bidder.

#### 24. Bid Opening

The Officer inviting the tender or his duly authorized assistant will open the tenders in the presence of intending tenderers who may be present at the time in person or through their authorized representative. In the case of the tenders invited under Two Cover System, the technical bids of the tenders received will be opened first.

**Technical Bid**: Technical Bid shall be opened in the office of the *Chief Mechanical Engineer*, *Cochin Port Trust* after 15.30 Hours on the last date fixed for receiving the Tenders. Submission of EMD and Cost of document is verified initially. In case the earnest money and cost of bid document is not deposited or is not in order, the Bid will not be opened further and hard copy submitted will be returned.

If all Bidders have submitted unconditional Bids together with requisite Bid security, then all Bidders will be so informed then and there. If any Bid contains any deviation from the Bids documents and /or if the same does not contain Bid security in the manner prescribed in the Bid documents, then that Bid will be rejected and the Bidder will be informed accordingly. The Price Bid submitted in e- mode will not be opened.

In the event of a tender being rejected, the earnest money paid with such unaccepted tender shall be refunded to the tenderer.

#### 25. Bid Opening – Price Bid

Price Bid of those Tenderers found responsive in the evaluation of Technical bid, will be opened later. The date and time of opening of the Price Bid will be announced in the e-tender portal; separate communication will not be sent to the bidders. The Bidder's name, the Bid prices, the total amount of each Bid, any discounts, Bid modifications and withdrawals, and such other details as the Employer may consider appropriate, will be announced by the Employer at the time of opening.

#### 26. Clarification of Bids

To assist in the examination and comparison of Bids, the Employer may, at his discretion, ask any Bidder for clarification of his Bid, including breakdown of unit rates. The request for clarification and the response shall be in writing, but no change in the price or substance of the Bid shall be sought, offered, or permitted.

No Bidder shall contact the Employer on any matter relating to his bid from the time of the bid opening to the time the contract is awarded. If the Bidder wishes to bring additional information to the notice of the Employer, he should do so in writing.

Any effort by the Bidder to influence the Employer's bid evaluation, bid comparison or contract award decisions, may result in the rejection of his bid.



#### 27. Examination of Bids and Determination of Responsiveness

- 27.1 Prior to detailed evaluation of Bids, Cochin Port Trust will determine whether each Bid:
  - (a) meets the Minimum Eligibility Criteria defined in Clause 12.
  - (b) has been properly signed by an authorised signatory (accredited representative) holding Power of Attorney in his favour. The Power of Attorney shall interalia include a provision to bind the Bidder to settlement of disputes clause;
  - (c) is accompanied by the required Bid security and;
  - (d) is responsive to the requirements of the Bidding documents.
  - (e) A responsive Bid is one which conforms to all the terms, conditions and specification of the Bidding documents, without material deviation or reservation. A material deviation or reservation is one which affects in any substantial way the scope, quality or performance of the Works;
    - i. which limits in any substantial way, the Employer's rights or the Bidder's obligations under the Contract; or
    - ii. whose rectification would affect unfairly the competitive position of other Bidders presenting responsive Bids.
    - iii. Undertakes in the Technical Bid that he has not incorporated any conditions in the Financial Bid.
- 27.2 If a Bid is not substantially responsive, it shall be rejected by the Employer, and may not subsequently be made responsive by correction or withdrawal of the non-conforming deviation or reservation.

#### 28. Correction of Errors:

Bids determined to be responsive will be checked by the Employer for any arithmetic errors. Errors will be corrected by the Employer as follows:

- (a) Where there is a discrepancy between the figures and in words, the words will govern;
- (b) The amount stated in the Bid will be adjusted by the Employer in accordance with the above procedure for the correction of errors and, with the concurrence of the Bidder, shall be considered as binding upon the bidder. If the Bidder does not accept the corrected amount, the Bid shall be rejected and the Bid security shall be forfeited in accordance with Clause 16.

#### 29. Evaluation and Comparison of Bids:

The Employer will evaluate and compare only the Bids determined to be responsive in accordance with Clause 27. In evaluating the Bids, the Employer will determine for each Bid the evaluated Bid Price by adjusting the Bid Price as follows:

- (a) making any correction for errors pursuant to Clause 28;
- (b) making appropriate adjustments to reflect discounts or other price



modifications offered.

In order to determine the lowest evaluated bid price, the total price of all the 14 line items mentioned in the Bill of Quantities will be considered by the Employer.

#### **30.** Alteration of tender documents:

No alteration shall be made in any of the tender documents or in the Bill of Quantities and the tender shall comply strictly with the terms and conditions of the tender document. The Employer may however ask any tenderer for clarifications of his tender if required. Nevertheless, no tenderer will be permitted to alter his tender price after opening of the tender.

#### 31. Alternative conditions and Proposal:

The Tenderer shall note that alternative or qualifying tender conditions, or alternative design proposal for whole or part of the work will not be acceptable. Tenders containing any qualifying conditions or even Tenderer's clarifications in any form will be treated as non-responsive and will run the risk of rejection. Price Bid of such Tenderer's will not be opened.

#### 32. Award of Contract:

The Employer will award the Contract to the bidder whose bid has been determined to be responsive to the bidding documents and who has offered the lowest evaluated bid price, provided that such bidder has been determined to be

- (a) Eligible in accordance with the provisions of Clause 12, and
- (b) Qualified in accordance with the provisions of Clause 12.

#### 33. Release of Bid Security / EMD:

The Bid Security / EMD of unsuccessful bidder other than L1 and L2 will be refunded immediately after ranking of the Bids. The bid security of L2 bidder shall be refunded immediately after entering into agreement with L1 bidder and acceptance of the Performance Security. The Bid Security of the successful bidder will be discharged after he has signed the Agreement and furnished the required Performance Security.

#### **34.** Performance Security:

- 34.1 Within not later than 21 days for domestic bids and 28 days for international bids from the date of the Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance Security in the form of Bank Guarantee (BG) for an amount equivalent to 10% of the Contract price rounded off to the nearest Rs. 1000/- in the following forms:
  - (i) Banker's Cheque / Demand Draft / Pay Order of a Scheduled Bank.
  - (ii) An irrevocable Bank Guarantee (BG) enforceable and encashable at Cochin, drawn from any scheduled bank operating in India as per the proforma.
- 34.2 If the performance security is provided by the successful Bidder in the form of



a Bank Guarantee, it shall be issued by a Nationalised / Scheduled Indian bank having its branch at Kochi acceptable by *Cochin Port Trust*. The BG shall be issued in favor of *Cochin Port Trust* in the Format enclosed in Annexure A of Section II.

34.3 In the event of the tenderer, after the issue of the communication of acceptance of offer by the Board, failing /refusing to execute the agreement as hereinafter provided, the tenderer shall be deemed to have abandoned the contract and such an act shall amount to and be construed as the Contractor's calculated and the willful breach of the contract, the cost and consequence of which shall be to the sole account of the tenderer and upon such an event the Board shall have full right to claim damages therefore either together with or in addition to the forfeiture of Earnest Money Deposit.

#### 35. Signing of Agreement:

The successful tenderer will be required to execute an Agreement at his expense within 28 (twenty eight) days from the date of work order, on proper value Kerala State Stamp Paper in the prescribed form. The agreement as finally executed will include the Employer's Bid Documents and the Bidder's offer as finally accepted by the EMPLOYER together with addendum/corrigendum, bid clarification and all correspondences exchanged between EMPLOYER and the bidder, if any. Till the formal agreement is executed, the Letter of Acceptance together with the offer as finally accepted along with correspondences shall form a binding contract between the two parties.

#### 36. Fraud and Corrupt Practices:

The bidder and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this document, the Port shall reject the tender without being liable in any manner whatsoever to the bidder, if it determines that the bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices") in the Selection Process. In such an event, the Port shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Port for, inter alia, time, cost and effort of the Authority, in regard to the Tender, including consideration and evaluation of such Bidder's Proposal. Such Bidder shall not be eligible to participate in any tender or RFP issued by the Authority during a period of 2 (two) years from the date such Bidder is found by the Authority to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.

For the purposes of this Clause, the following terms shall have the meaning hereinafter respectively assigned to them:

(a) "corrupt practice" means



- (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the Selection Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly with the Selection Process or the LOA or has dealt with matters concerning the Agreement or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Selection Process; or
- (ii) engaging in any manner whatsoever, whether during the Selection Process or after the issue of the LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical consultant/ adviser of the Authority in relation to any matter concerning the Project;
- (b) "fraudulent practice" means a misrepresentation or omission of facts or disclosure of incomplete facts, in order to influence the Selection Process;
- (c) "coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the Selection Process;
- (d) "undesirable practice" means
  - (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or
  - (ii) having a Conflict of Interest; and
- (e) "restrictive practice" means forming a cartel or arriving at any understanding or arrangement among Applicants with the objective of restricting or manipulating a full and fair competition in the Selection Process.

#### 37. Rejection of Tender:

Any Tender not conforming to the foregoing instructions will not be considered. The Employer does not bind himself to accept the lowest or any tender and has the right to reject any tender without assigning any reason thereof. No representation whatsoever will be entertained on this account.

Note:- The area mentioned above is only approximate. The contractor shall be required to augment to the list of required materials, based on the actual verification at site.

#### 3. PAINTING SCHEME

**3.1 Surface preparation**: The corroded/ rusted areas of the Marine Loading Arms (MLAs), pipe lines, tower structures etc. shall be thoroughly cleaned by Scrapping/chipping, using mechanical/ hand tools/ emery paper and also by using suitable cleaning agent. The other areas (non-corroded) shall be cleaned thoroughly using a cleaning agent to remove the impurities completely.

#### 3.2 Application:

- a. **Primer for the cleaned bare surface area**: After surface preparation, one coat (135-150 μm) of Epoxy mastic high build primer shall be applied on dry bare surface immediately to avoid oxidation, in the presence of Engineer-in-charge/authorized representative.
- b. **Finish Coat**: One coat (**100-125 μm**) of Poly siloxane finish coat shall then be applied over the complete area as per the Scope of work. The final shade shall be slightly different from the existing colour with the approval of the Engineer-in-charge.
- **3.3** During unfavourable weather condition painting shall be avoided. The Engineer-in-charge/ authorized representative shall have the discretion to insist on recleaning, as may be required before primer application is taken up.

**3.4** The Paints used shall be Akzo Nobel/ Zigma/ Jotun/ Asian Paints/ Berger. The primer as well as the paint for finish coat shall be of same brand and shall be got approved by the Engineer-in-charge/ authorized representative at site before application. The primer as well as the finishing coat shall be applied as per the manufacturer's procedure and the interval for the application of the primer and the finishing coats should be strictly adhered to as per manufacturer's instruction. The opening up of the primer and paint containers shall be done in the presence of supervising engineers of Cochin Port and mixing is to be carried out as per the manufacturer's instructions. No thinner, turpentine, kerosene or any other agent will be allowed to be added along with the paint for any purpose other than those specified by the manufacturer. If any work area or any other place get spoiled got damaged or affected while carrying out the work, the same should be cleaned and made good at the contractor's sole risk and cost, to the entire satisfaction of the engineer-in-charge or his authorized representative. The contractor should make his own arrangement to build necessary scaffolding for painting the structure at height.

#### **3.5** Inspection:

The Contractor shall offer the completed portion of work in each of the following stages for inspection of Engineer in-charge/ authorized representative:

- (i) Surface preparation
- (ii) Primer application
- (iii) Finish coat of paint.

The contractor is required to obtain approval of the Engineer in-charge/ authorized representative at each of the above stages of work before proceeding to the next stage. Any defects noticed during the stage inspection shall be rectified by the contractor to the entire satisfaction of Engineer in-charge/ authorized representative, before proceeding to the next stage.

#### 4. Site Conditions

#### 4.1 Location & Access to site

The location of the work is Cochin Oil Terminal(COT) of Cochin Port Trust situated in the Ernakulam Channel at Willingdon Island, Cochin -682 009. As Cochin Oil Terminal is situated in the Ernakulam Channel, there is no road access to reach at COT. The means of access to COT is by Boat either from Ernakulam Boat Jetty or from Willingdon Island. The Contractor shall arrange proper means of transport of his own, for transporting his materials, equipments & fixtures, labour etc. to the worksite to execute the contract.

#### **4.2 Wind**

Wind at Cochin is highly influenced by the land and sea breezes. Wind direction changes from north-east during morning hours to west during evening for the period of October to May. During peak of south-west monsoon, especially from June to September, predominant wind direction remains south-west both during morning and evening hours. Due to strong monsoon winds, effect of land winds is not dominant during south-west monsoon. During the non-monsoon periods, the predominant wind direction is from north east during the morning and west during the evening which shows influence of land breeze.

#### 4.3 Rainfall

The climate is characterized by dry and wet seasons. The wet seasons starts in late May and ends in November. During this period, two monsoons pass by one after another. The major monsoon is south-west monsoon which lasts from June to September. This is followed by north-east monsoon during October and November. The average annual rainfall is about 3000mm; and the major portion is during south-west monsoon.

#### 4.4 Temperature

Cochin experiences moderate temperatures throughout the year. The temperature varies from 22°C to 34°C. The low temperature occurs during the southwest monsoon, December and January. Daytime temperature goes upto 30°C even during this period. The hot months are from March to May.

#### 5. Time for Completion

**5.1** The time allowed for carrying out the work as mentioned in the memorandum shall be strictly observed by the Contractor. The work shall throughout the time

period be proceeded with diligence, time being deemed to be the essence of the contract.

**5.2** The whole work shall be completed in the stipulated time, accordance with the provisions under Memorandum included under "Form of Tender" or such extended time as may be allowed under clause 29 of Conditions of Contract included in the GCC.

#### 6. Time Schedule and monitoring of progress

- **6.1** The successful tenderer shall prepare and furnish immediately on the receipt of LoA a detailed work schedule indicating key activities and critical items for completing the work within the stipulated contract period, for the approval of Engineer-in charge. This time schedule forms the basis for monitoring the progress of work. The work shall be arranged in the order of preference and completed as directed by the Engineer-in-Charge of work.
- **6.2** The contractor shall submit to the Engineer-in-charge on the first day of each week, a program report in the approved proforma, for the succeeding period showing up-to-date progress during the previous period of contract on all important items /portion of the work indicating delay, if any, its reason and proposal to cover up the delay so as to complete the work within the specified completion period.

#### 7. Facilities to be provided by the Port

#### 7.1 Temporary Storage area:

Cochin Port shall provide a covered space at free of cost to the contractor for keeping their materials, tools and other belongings etc. The security of the items kept at the site will be vest with the contractor and Port will not be responsible for any loss.

#### **7.2 Power**

Electric power required for the work can be supplied by Cochin Port from the nearest existing line of the Port Trust at prevailing rates. The cost of drawing temporary lines/ cables/ providing switches and making connection and metering arrangements etc, shall be borne by the Contractor. If there is any disruption in the power supply due to supply failure/ restrictions imposed by the Kerala State Electricity Board, the department shall not be held responsible and the Contractor has to make suitable alternative arrangements at their cost.

#### 8. Contractor's responsibility

- **8.1** All materials for use on the works shall be supplied and provided by the Contractor at his own cost.
- **8.2** Samples of Primer/Paint required for the work, shall be got approved by the Engineer-in-Charge before procurement.
- **8.3** The Contractor shall thoroughly study the Scope of work and specifications and errors/omissions/modifications if any shall be brought to the notice of the

- Engineer-in-Charge well in advance so that a final decision in the matter could be given in time.
- **8.4** The contractor himself has to ascertain the labour situation and trade union practices prevailing at the site. Settling of any dispute with the labour will be Contractor's responsibility, so as not to affect the work. All labour, skilled or unskilled shall be provided by the Contractor.
- **8.5** The Contractor shall be solely responsible for any damage or injury to the persons or things caused or suffered during the execution of the work and these shall be made good or compensated at his risk & cost.
- **8.6** The Contractor shall prior to commencement of the work insure in the joint names of the Employer and the Contractor against all loss or damage from whatever cause arising for which he is responsible under the terms of Contract.
- **8.7** The contractor shall execute the work in such a manner that all the existing structures overhead lines, existing pipelines, utilities, etc. are not disturbed /altered / damaged. Any damages caused shall be made good by the Contractor at his own risk and cost.
- **8.8** All plants and equipment and consumables required for the whole work shall be provided by the Contractor at his own cost.
- **8.9** The Contractor shall not construct any structure, even of temporary nature, for any purpose at site, except with the written permission of the Engineer-in-Charge of the work and any construction so put up shall be removed by the Contractor whenever the Engineer-in-Charge calls upon the Contractor to do so.
- 8.10 The scrap materials generated during the execution of work shall be cleared off from the Cochin Oil Terminal, at the risk and cost of the contractor. While disposing the scraps all the regulatory requirements have to be complied with. The contractor shall take care to clean the work site from time to time for easy access to the work-site and also from safety point of view. Work site should always be kept clean to the entire satisfaction of the Engineer-in-charge/authorized representative. Before handing over the site to Cochin Port Trust on satisfactory completion of work, the contractor, in addition to other formalities to be observed as detailed in the document, shall clear the site at his own expense and leave the whole area used by him in clean and tidy condition to the entire satisfaction of the Engineer-in-charge.
- **8.11** The Contractor shall observe the conservancy rules relating to the Port and shall always take necessary steps to keep the Port water free of noxious or unhygienic matter due to the work, as are required by the Engineer-in-Charge. Under no circumstances, inflammable materials be allowed to spill into Port waters.
- **8.12** Qualified Engineers with sufficient experience in works of similar nature shall be available at site throughout the contract period during working hours in order to receive instructions from the department and to implement them properly and in time

- **8.13** The information and data detailed elsewhere in the tender document are furnished for general information and guidance only and the Port Trust in no case will be held responsible for the strict accuracy thereof or any deduction, interpretation or conclusion drawn by the tenderer.
- **8.14** The Cochin Port is an International Ship & Port Facility Security (ISPS) code compliant Port and the Contractor is obliged to comply with the provisions of the code in force and as amended from time to time.
- 8.15 The Contractor shall remove all materials brought to work site / stacked at the work site or anywhere else within the Port area and clear the site at his cost to the full satisfaction of the Engineer-in-Charge before the site is returned to the Port Trust. All such materials including tools & plants etc. shall be taken away from the location and shall be cleared in every respect and to reinstate to its original condition at no extra cost to the Port Trust immediately after completion of the work. In case, any such material is found left in the work site or anywhere in the Port area, disposed off such items at the risk and cost of the Contractor, after issuing two notices giving 15 days' time each for removing the material. All expenses incurred on this shall be recovered by disposing off the material if any confiscated. If any balance amount still remains to be realized that will be recovered from the Contractor by appropriate means.

#### 9. Safety and Security:-

- 9.1 The Contractor shall take all care and precautionary measures for avoiding any kind of damage/accident in the work site on any account. The department shall not entertain any claim from the Contractor whatsoever towards compensation for any damage/accidents at the site due to negligence from his part, during the execution of work.
- 9.2 The Contractor shall take all care and precautionary measures for avoiding damage or accidents to the work. The department will not entertain any claim from the Contractor whatsoever, towards compensation for any such damage or accident occurring during the execution of the contract.
- 9.3 The Contractor shall observe all safety regulations during the execution of the work. Safety measures, precautions, barricading, warning signals etc. shall be done at the Contractor's cost as directed by the Engineer-in-Charge of the work.
- 9.4 Being hazardous area all safety precautions should be under taken while executing the work under the instruction of Dock Master/Authorised representative of Cochin Port Trust. Normally all works shall be executed at Tanker Berths during the day time only. If any work is to be carried out other than this time, the contractor may obtain prior permission in writing from the Dock Master, Cochin Port Trust.
- **9.5** The contractor shall carryout hot work at the Tanker Berths only when the berth is free of ship. To carry out hot work at the tanker berths prior sanction of

- Dy. Conservator/Dock Master shall be obtained in writing by giving advance intimation to him about the date, time and nature of work.
- 9.6 The Contractor shall provide all necessary personnel protective equipments such as helmet, lifeguard, goggles, boots etc. as per the relevant rules and regulations, to the workmen at his own risk and cost. It shall be the Contractor's responsibility to ensure that the workmen make use of the personnel protective equipments during the execution of the work. The contractor shall ensure that all the personnel engaged for work at height should wear safety belts of prescribed standards as per the relevant regulations.
- **9.7** The work shall be arranged by the Contractor without causing any hindrance to the operation of the Cochin Oil Terminal. No damage shall be caused to the structures in the area, vessels operating in the area or otherwise by the Contractor's operations. Any damage or accident caused by the Contractor's operations shall be compensated / made good at the Contractor's risk and cost. The Contractor shall take all precautions for not to damage any cables / pipelines etc. passing through the area of work and if any damage is caused by him, the same shall be rectified at his own risk and cost.
- **9.8** The instruction / procedures recommended by the Fire/ Safety Divisions of Cochin Port Trust, and approved by the Dock Master, Cochin Port Trust shall be complied with.
- **9.9** The contractor shall take necessary precautions and comply with Rules, regulation, bye –law, applicable code and safe working practices.
- **9.10** All safety protection / precaution as per Statutory and Regulatory requirements for the safety of the workmen, supervisors and materials are to be provided by the contractor.
- **9.11** The contractor shall furnish the list of employees working under him at the tanker berths before starting the work. Any change in employees shall be made only with prior permission of Engineer-in-charge. The Contractor shall ensure that no labourers with criminal background are engaged for the work.
- **9.12** All employees of the contractor working at the site shall have a valid entry pass issued by the Security Officer, Cochin Port Trust. Entry passes will be issued only to those employees who are covered under the insurance.

#### 10. Workmanship

10.1 The whole Work shall be completed in a diligent manner within the contract period and defect or imperfection if any, observed during the defect liability period/ guarantee period, shall be rectified at Contractor's cost to the full satisfaction of the Engineer-in-Charge within the time allowed.

#### 11. Temporary Works

11.1 All scaffolding, staging, bracing and other temporary works required for proper execution of the works, shall be provided by the Contractor at his own cost, unless stated otherwise and that should be inclusive of all materials, labour, supervision and other facilities. The layout and details of such temporary works

shall have prior approval of the Engineer-in-Charge, but the Contractor shall be responsible for proper strength and safety of the same. All temporary works shall be so constructed as not to interfere with any permanent work or with the work of other agencies. If it is necessary to remove any of the temporary works at any time to facilitate execution of works or work by other agencies, such removal and re erection, if required, shall be carried out by the Contractor at the direction of Engineer-in-Charge without any delay and any extra cost on this account shall be borne by the Contractor.

11.2 On completion of the works, temporary works if any provided by the Contractor shall be removed from the site and the area shall be reinstated to the original condition at his own risk and cost.

#### 12. Working Time

Normally all works shall be executed at Tanker Berths during the day time only. If the Contractor wishes to carry out the work beyond normal working hours and or on holidays, the contractor should get specific prior approval in writing from the Dock Master, CPT.

#### 13. Alterations and Additions

The Employer shall have power and authority from time to time and at all times to make amendments or additions or alternations or changes in the scope of the work, and specifications, drawings and bill of quantities and give such further instructions and directions as may appear to the Employer necessary and proper for the guidance of the Contractor and the good and efficient execution of the works and the Contractor shall receive, obey and be bound by the same according to the true intent and meaning thereof as if the same had been mentioned or referred to in the scope of the work, of Quantities and Schedules. The Employer may also specifications, Bill vary or alter any of the works contemplated or may order any of the works contemplated thereby to be omitted, with or without the substitution of any other works in lieu thereof, or may order any work or any portion of works executed or partially executed to be removed, changed or altered, if required, and may order that other work shall be substituted in lieu thereof and any difference in the cost occasioned by any such diminution or alteration so ordered and directed shall be added to or deducted from the Contract Price based on rates available in the contract or where the rates are not specified a suitable rate backed up by rate analysis shall be submitted by Contractor and agreed upon between the Contractor and the Employer. In the event of disagreement, the Employer shall fix such rates or prices as shall in their opinion, be reasonable and proper having regard to the circumstances. The Contractor shall give to the Employer, a statement in writing of any extra work which he may have performed before submission of final bill, failing which any claim for which he may afterwards make for payment on account of any such extra work will not be allowed.

#### **SECTION -III**

#### **COCHIN PORT TRUST**

#### 2. SPECIAL CONDITIONS OF CONTRACT

#### 1. **GENERAL**

Special Conditions shall be read in conjunction with the General Conditions of Contract, Specifications and any other document forming part of this Contract wherever the context so requires.

Notwithstanding the Sub-division of the documents into these separate sections every part of each shall be deemed to be supplementary to and complementary of every other part and shall be read with and into the Contract so far as it may be practicable to do so.

Where any portion of the General Conditions of Contract is repugnant to or at variance with any provision of the Special Conditions, the provisions of the Special Conditions shall be deemed to over-ride the provisions of the General Conditions of Contract and shall to the extent of such repugnancy of variations, prevail.

#### 2. **MEASUREMENTS OF WORK DONE:**

- 2.1. In addition to the Clause-26 of GCC 'Computerised Measurement Book', measurement of the work can also be done as detailed below.
- 2.2. Engineer in-charge/ or his authorized representative shall, except as otherwise provided, ascertain and determine by measurement the value in accordance with the Contract of work done.
- 2.3. All measurement of all items having financial value shall be entered in Measurement Book and/or level field book so that a complete record is obtained of all works performed under the Contract.
- 2.4. All measurements shall be taken jointly by the Engineer in-charge/ or his authorised representative and by the Contractor or his authorised representative from time to time during the progress of the work and such measurements shall be signed and dated by the Engineer's Nominee and the Contractor or their representatives in token of their acceptance. If the Contractor objects to any of the measurements recorded, a note shall be made to that effect with reason and signed by both the parties.
- 2.5. The Contractor shall, without extra charge, provide all assistance with every appliance, labour and other things necessary for measurements and recording.
- 2.6. Except where any general or detailed description of the work expressly shows to the contrary, measurements shall be taken in accordance with the procedure set forth in the specifications notwithstanding any provision in the relevant Standard Method of measurement or any general or local custom. In the case of items which are not covered by specifications, measurements shall be taken in accordance with the relevant standard method of measurement

issued by the Bureau of Indian Standards and if for any item no such standard is available then a mutually agreed method shall be followed.

#### 3. LIQUIDATED DAMAGES

For levying LD as per Clause-49 of General Conditions of Contract, the Employer is not required to have documentary evidence to quantify or prove the losses suffered by the Employer due to delay in completion of work by the Contractor, as per agreement conditions.

#### 4. INSURANCE OF WORKS

- 4.1. The insurance cover for the loss of or damage to the works, plant, materials and equipment stated in the clause 13 of GCC shall be as follows:
  - a) The insurance cover for the works for the time being executed to the estimated current contract value thereof plus 10(ten) percent thereon to allow any additional costs and professional fees resulting from the loss or damage.
- 4.2. It shall be the responsibility of the Contractor to notify the insurer of any change in the nature and extent of the works and to ensure the adequacy of the insurance cover at all times in accordance with the provisions of this clause.

## 5. PAYMENTS OF SALARY / WAGES AND OTHER BENEFITS ETC. TO CONTRACT / CASUAL WORKERS

- 5.1. The Contractors shall make all payments of salary/wages and other benefits etc. to the contract / casual workers deployed for the work through Bank / Cheque only.
- 5.2. All the payments to the Contractors would be released only on submission of an undertaking to comply with Clause 5.1. above.

#### 6. **DEFINITIONS**

6.1 **Market Rate** under Clause 1 of General Conditions of Contract shall be replaced and modified as below:

Market Rate is the rate as decided by the Engineer on the basis of the cost of materials and labour at the site where the work is to be executed plus 15% to cover all overheads and profits.

#### 7. MODIFICATIONS TO GCC

The following clauses of General Conditions of Contract (GCC) shall be replaced and modified as below.

#### 1. **DEFINITIONS**

(Following Definitions shall be replaced as)

The **Completion Date** is the date of completion of the Works as certified by the Engineer or his nominee in accordance with Sub Clause **56.1** 

Market Rate is the rate as decided by the Engineer on the basis of the cost of materials and labour at the site where the work is to be executed

plus 15% to cover all overheads and profits.

17. The following Sub-clause is added as "17.2" under Clause 17 "The Works to be completed by the Intended Completion Date"

The entire work as per scope of work indicated under Section III should be completed within 45 calendar days (including Sundays and Holidays) from the date of receipt of Employer's Letter of Acceptance by the Contractor. If the work is not completed within the stipulated time, liquidated damages, as per clause 49 of General Conditions of Contract will be applicable. In case work could not be carried out due to the shipping movement, rain or any other requirement of Cochin Port Trust, such days will not be reckoned for calculating the completion period. The contractor shall maintain a record of such days lost due to above-mentioned reasons duly counter- signed by the Engineer-in-charge.

#### 26. COMPUTERIZED MEASUREMENT BOOK

(6<sup>th</sup> para shall be replaced as)

The Contractor shall also submit to the department separately his computerized Abstract of Cost and the bill based on these measurements, duly bound, and its pages machine numbered along with **three** spare copies of the bill. Thereafter, this bill will be processed by the Division Office and allotted a number as per the computerized record in the same way as done for the measurement book meant for measurements

36. The following Sub-clause is added as "36.7" under Clause 36 "Defect Liability" Painting works shall be guaranteed for a period of 12 months from the date of completion of the entire work and certified by the Engineer in Charge. The Contractor shall guarantee that the chemical and physical properties of the paint materials used are in accordance with the specification contained herein. The contractor shall rectify free of cost any defects that may occur during this period. If the defects are not rectified by the contractor within the period of one month, the guarantee period will be extended further by the period of lapse from the contractor's side. In case of any disputes as to whether any materials/ workmanship is defective, the decision of the Chief Mechanical Engineer, Cochin Port Trust shall be final and binding.

#### 40. PAYMENTS FOR VARIATIONS

(Clauses 40.2 and 40.3 shall be replaced as)

40.2 For items not existing in the Bill of Quantities or substitution to items in the Bill of Quantities, rate payable should be determined by methods given below and in the order given below:

- i) Rates and prices derived from the rate of similar items in Contract.
- ii) Rates and prices in the Schedule of Rates applicable to the Contract plus Ruling percentage.
- iii) Market rates of materials and labor, hire charges of plant and machinery used, plus 15% for overheads and profits of Contractor.
- 40.3 For items in the Bill of Quantities but where quantities have increased beyond the variation limits, the rate payable for quantity in excess of the quantity in the Bill of Quantity plus the permissible variation shall be as determined by methods given below:
  - i)Rates and prices in the Schedule of Rates applicable to the Contract plus Ruling percentage.
  - ii) Market rates of material plus 15% for overheads and profits of Contractor whichever is lower, but not less than the rate in the Bill of Quantities

#### 43. PAYMENTS

(Clause 43.3 shall be replaced as)

- 43.3.1 The contractor shall be entitled upon certificates of the Engineer or his nominee to payments in accordance with the following provisions:-
- (i) No advance payment shall be made.
- (ii) On completion of the works mentioned under Sl. No. (1) and (9) of BOQ which are of priority and to be completed first, 20% of the total work order value will be released.
- (iii) Balance payment shall be made on satisfactory completion of all the remaining painting works as certified by the Engineer-in-Charge and handing over the site to Cochin Port Trust. The final payment will be effected based on actual measured quantity of work as certified by the Engineer-in-Charge.

#### 44. COMPENSATION EVENTS

Clauses 44.1 (c) to (e) - Deleted.

#### 45. RATES FOR ITEMS TO BE INCLUSIVE OF TAXES

45.1 The rate quoted by the Contractor shall be inclusive of the cost of provision of plant and equipment, materials, labour, execution, supervision, maintenance, overheads and profits and every incidental and contingent cost and charges whatsoever excluding Goods and Service Tax (GST). GST as may be applicable from time to time shall be shown separately in the invoice. The Employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law. Any new Taxes, levies, duties imposed after signing the Contract shall be reimbursed by the Employer on production of documentary evidence.

The invoice to be submitted by the Contractor should include the GST Registration Number of the Contractor as well as the Employer.

#### **52. SECURITY DEPOSIT**

The Clause 52 of the General Conditions of Contract related to the Security Deposit, stands modified to the extent detailed below:

- (i) In all cases, the Performance Guarantee retained till end of Defect Liability Period shall be 10 % of the Contract Value or Cost of Work Done, whichever is higher.
- (ii) Wherever the cost of work done exceeds the contract value, the total amount retained as Security deposit, considering the Performance Guarantee initially submitted shall amount to 10 % of the Cost of Work Done, at all times.

#### 52. SECURITIES

(Clauses 52.2 shall be replaced as)

**52.2 Performance Security** shall be 10% of the Contract value.:

#### 80. TAXES AND DUTIES

The Contractor and his staff shall be responsible for payment of all personal income taxes to the concerned authorities as per the law in force from time to time. Deduction of Income Tax shall be made by the Employer from each certificate of payment to the Contractor at the rate of 2% plus surcharge or such other rates as may be specified by the Central Government from time to time, on the gross amount of the Contractor's bill for payment.

**80.4** The Contractor shall comply all the GST Regulations viz. timely uploading of bills, issue of debit/ credit notes etc.

(d) <u>Maternity Benefit Act 1961 or Maternity Benefit Amendment Act 2017</u>:- The Acts provides for leave and some other benefits to workmen/employees in case of confinement or miscarriage etc.

#### (l) <u>ESI Act, 1948:-</u>

(i) As per the Govt. Notification dt. 20.7.09, Cochin Port Trust has registered under the ESI Act with ESI Corporation and provision of ESI Act, 1948 are applicable to contract/casual employees drawing wages/Salary upto **Rs.20,000/-** per month and working in Cochin Port Trust. Workers covered under ESI

Act, are entitled for full medical care for self and family. Besides, cash benefit in the event of sickness, maternity and employment injury. Accordingly, the contractual/casual employees drawing wages upto **Rs.20,000/-** per month employed either directly by Port Trust or through contractor are covered under ESI Act, 1948. It is obligatory on the part of the employer to calculate and remit ESI contribution comprising of employers' share of 4.75% plus employees' share of 1.75% which is payable on or before 21st of the following month, to which the salary relates.

# SECTION –IV COCHIN PORT TRUST 1. PREAMBLE TO BILL OF QUANTITIES

#### 1. General Instructions

#### 1.1. General

- 1.1.1. This Bill of Quantities must be read with the Conditions of Contract and the Specifications, and the Contractor shall be deemed to have examined the Specifications, General Conditions of Contract and to have acquainted himself with the detailed descriptions of the Works to be done, and the way in which they are to be carried out.
- 1.1.2. Notwithstanding that the Work has been sectionalized every part of it shall be deemed to be supplementary to and complementary of every other part and shall be read with it or into it so far as it may practicable to do so.
- 1.1.3. The detailed descriptions of Work and materials given in the Specifications are not necessarily be repeated in the Bill of Quantities.
- 1.1.4. The Contractor shall be deemed to have visited the Site before preparing his tender and to have examined for himself the conditions under which the Work will proceed and all other matters affecting the carrying out of the Works and cost thereof.
- 1.1.5. The Bidder will be held to have familiarized himself with all local conditions, in so far as they affect the Work, means of access and the locality of existing services, in order to execute the Works measured and described hereinafter. No claims for want of knowledge in this respect will be reimbursed.

#### 1.2. Rates and Prices to be Inclusive

- 1.2.1. Rates and prices set against items are to be the all inclusive value of the finished Work described in the Specification or which can reasonably be inferred there from and are to cover the cost of provision of plant, labour, supervision, materials, test charges, freight, transportation, performance of Work, care of Works, insurance, maintenance, overheads and profits and every incidental and contingent cost and charges whatsoever excluding Goods and Service Tax (GST), but including every kind of temporary Work executed or used in connection therewith (except those items in respect of which provision has been separately made in the Bills of Quantities) and all the Contractor's obligations under the Contract and all matters and things necessary for the proper completion of works.
- 1.2.2. The Specifications are intended to cover the supply of material and the execution of all Work necessary to complete the Works. Should there be any details of material which have not been referred to in the Specifications or in the Bill of Quantities, but the necessity for which may reasonably be implied or inferred there from, or which are usual or essential to the completion of all Works in all trades, the same shall be deemed to be included in the rates and

prices entered in the Bill of Quantities. The rates and prices are to cover the item as described in the Bill of Quantities and if there is inconsistency in the description between the Bill of Quantities, Specifications, the interpretation will be done according to General Conditions of Contract.

- 1.2.3. The quantities given in the Bill are approximate and are given to provide a common basis for tendering. They are not to be taken as a guarantee that the quantities scheduled will be carried out or required or that they will not be exceeded. The Employer / Engineer reserves the right to delete any item and / or increase / reduce quantities indicated in the Bills of Quantities at any time. Payment will be made according to the actual quantities of Work ordered and carried out in the contract. However, the rates quoted shall be valid for any extent of variation in quantity of each individual item provided that the total contract value does not get altered by more than indicated in conditions of contract. No claim whatsoever for extra payment due to variation of quantities within the above said limit would be entertained.
- 1.2.4. The rates and prices shall include (except where separate items are given) for the provision and operation of the following items, for compliance with the Condition of Contracts, Special Conditions, the specifications and Tender drawings:
  - i) Supervision and labour for the Works;
  - ii) All materials, installation/erection, handling and transportation;
  - iii) All Contractor's Equipment;
  - iv) All testing, commissioning, insurance, maintenance, security, welfare facilities, overheads and profit and every incidental and contingent costs and charges whatsoever including;
  - v) All temporary fencing, watching, lighting, sanitary accommodation, general security arrangements, welfare facilities and first aid provision;
  - vi) All necessary temporary services including fresh water, compressed air lines, electrical cabling etc.
  - vii) The maintenance of all Contractor's services:
  - viii) All insurances for the Works;
  - ix) Allow for complying with all environmental aspects as specified
  - x) For carrying out hot Work of any kind Contractor should consider safety of vessel in adjoining berth.
  - xi) Detail design of components of temporary Works, wherever necessary as directed by Engineer.

#### 1.3. Method of Measurement

Standard Method: The Work included in Bill of Quantities once completed will be presented to the Engineer's representative for checking quality and quantity of Work. The Engineer's representative after satisfying himself issue a certificate to that effect. The rates and prices shall include whatsoever allowance is considered to be necessary for wastages.

The mode of measurement and payment described in the relevant technical specifications shall apply for the relevant items.

### 1.4. Currency

1.4.1. All monetary reference herein and the Bill of Quantities shall be priced in Indian Rupee Currency.
