CLARIFICATION REGARDING SUBMISSION OF BID

- Sub: Design, Manufacture, Supply, Erection, Testing And Commissioning of 1 No. 15 Ton Rail Mounted ELL Crane for Indian Coast Guard including AMC for a period of 5 Years after two Years Guarantee Period – Clarification – Reg

Following Clarifications are offered regarding submission of Bid, in lieu of Covid-19 situation :

1. The Bidders may submit the MQC documents and all the documents required as per Tender Document **online** before the due date of submission of bid. The Bidders may prepare the Power of Attorney, Integrity Pact and other documents on Stamp paper as required in the TD and scan and submit the same on line. Originals may be submitted immediately after lock down / travel restrictions are withdrawn.
2. In addition to the ways mentioned in the Tender Document, the Bidders can also submit the Cost of Tender Document and EMD in the following options also.
 - a) The Bidders can submit the Cost of Tender Document and EMD via RTGS. UTR number of the transaction should be communicated to the e-mail id of the contact person of Cochin Port Trust ie. cme@cochinport.gov.in or dcmecept@gmail.com; at least one day before the date and time of opening of e-tender. CoPT will verify receipt of EMD as referred in the UTR number, in the Bank account of CoPT. **If Cost of TD/ EMD amount is not reflected in the Bank account of CoPT, the bid will be rejected.** Bank Details of Cochin Port Trust are given below:

 - b) The Bidder's may submit the DD in lieu of Cost of TD and BG in lieu of EMD through their Bank, under intimation to CoPT. The Bank may submit the DD and BG along with the proper authorization letter from the Bidder. **The Bidder's shall ensure that the originals are received in CoPT office, sufficiently before the due date and time of submission of Bid. Otherwise the Bid will be rejected.**
3. All other terms and conditions in the Tender Document remain unchanged.
