The bidders may note that the offers are invited only for budgetary purpose. Cochin Port is not bound to hire the Barge from the bidders based on the budgetary offer submitted.

**Scope of Work**

The detailed specification of the Water Barge to be hired is given below

The vessel should be capable of supplying Fresh Water under all weather conditions and registered under Kerala Inland Vessels Act or Merchant Shipping Act.

The specification given is only intended to cover the principal requirements and is not to be taken as complete in details. Any fittings or accessories which may not be specifically mentioned in the specification but which are usual or necessary are to be provided by the contractor without extra charge.

- a) LOA:** 35 Meters Maximum.
- b) Draft:** Maximum 5.0 Meters (fully loaded condition)
- c) Speed:** Not Less than 8 Knots in calm sea condition in loaded condition.
- d) Construction:** Steel
- e) Classification:** Built and maintained under IRS or any IACS member and the Water Barge must have all valid statutory and classification certificate for the performance of designed duties
- f) Registration:** I.V. Act or higher
- g) Equipment:** Must have AIS & VHF
- h) Age:** Not more than 10 years as on the date of tender submission.
- i) Endurance:** Fuel tank capacity minimum for 14 days continuous operations at full speed.
- j) Fresh Water Capacity:** Not less than 250 M Tonnes
- k) Fresh Water for Supply:** Will be Provided by CoPT
- l) Water Pump Capacity:** Should be able to pump out full tank capacity to a ship of 30 M freeboard within 5 Hours.
- m) Insurance:** The vessel must have valid insurance for Port risks from any under writers.
- n) Manning:** The manning for the Barge has to be provided as per Act and the crew must have valid certificate of Competency as applicable.
- o) Fuel:** Fuel will be provided by Cochin Port Trust on Port account. Lubricant, stores spares and all other running expenses to be borne by the contractor.
- p) Duration Contract:** 5 years + 2 Years option
- q) Nature of service-** 24 Hrs per day x365 Days.
