COCHIN PORT TRUST INVITATION OF EXPRESSION OF INTEREST (EOI) FOR ESTABLISHING A MULTI SPECIALITY HOSPITAL AT COCHIN PORT TRUST AREA, WILLINGDON ISLAND

SECTION I

GENERAL

Cochin Port is an all-weather Major Port under the Government of India, and is well connected by rail and by National Highways NH-544, NH-66 and NH-85. Willingdon Island forming major part of the Port area offers excellent connectivity by means of road and rail. Cochin International Airport is located just 35 km from Cochin Port.

Cochin Port, India's first e-Port is ISO: 9001-2015 certified, ISPS and MARPOL regulation compliant, offers round the clock navigation throughout the year.

The Port facilities are located mainly in Willindon Island of 356 ha area with the Administrative Office and the Oil, Dry Cargo and Cruise Terminals, apart from 203 ha at Vallarpadam, where the International Container Transhipment Terminal (ICTT) is functioning and 308 ha of area at Puthuvypeen where the LNG Terminal is located.

THE PROJECT

Cochin Port Trust has identified 4.05 ha (10.0 acre) of land at south end of Willingdon Island as per the Sketch attached for allotment on lease for a period of 30 years for establishing a Multispecialty Hospital by interested investors. Allotment of land will be done through tender-cum-auction procedure. This area, along the NH-966B provides fast access to West Kochi and also to Maradu and surrounding areas. The area will be handed over to the successful bidder in 'as is where is' condition.

QUALIFYING REQUIREMENTS

- a) The firm that submits the EoI should be a Registered Partnership Firm or Company or Joint Venture or Consortium or Societies or Trusts or other Statutory Bodies having an average annual financial turnover of Rs.50 Crore for the last 3 years ending 31st March, 2020.
- b) The firm should have 5 years of experience in administration and management of at least one 250-bed Multispeciality Healthcare Service / Hospital with all major specialities in India. If the bidder does not have 5 years experience, then they can constitute JV/Consortium with firms having experience

PROPOSAL

The proposed Multispeciality Hospital is intended for treating the general public and as a referral hospital for Cochin Port Trust. The successful bidder shall, at all times, reserve a minimum of 50 beds and all other facilities like various Specialist O.P.D. services, investigations in O.P.D. and I.P.D., O.P.D. and I.P.D. procedures / surgery, to be made available to the Sponsored Patients of Cochin Port Trust at CGHS rates, at all times on referral as and when required. The reservation of such beds (General ward, single room, A/C room) shall be as per the prevailing CGHS eligibility rules. All matters with reference to the treatment of the Sponsored patients will be regulated by the prevailing CGHS rules. The medical expenses of the sponsored patients of CoPT will be paid either by CoPT or directly by the patients. "Sponsored Patients" shall mean and include; 1) CoPT employees and dependants, 2) CISF employees and dependants, 3) Retired employees and spouses, and 4) Any other employees/personnel referred by Cochin Port Trust.

The allotment (lease) of land will be subject to the provisions of the Policy Guidelines for Land Management by Major Ports (PGLM, 2015), issued by the Govt. of India. The bidding parameter of the tender will be 'one-time upfront payment'. The Reserve Price of the upfront payment is Rs.34.13 Crore. The upfront payment shall be remitted, prior to allotment of the land. In addition to the above, the allottee shall pay a nominal lease rent of Re.1 per Sq m per year throughout the lease period of 30 years.

Interested firms, meeting the qualifying requirements as above are hereby invited to submit their "Expression of Interest" (EOI for establishing a Multi Speciality Hospital at Cochin Port Trust area, Willingdon Island). The information submitted will be treated as confidential.
