1. Notice inviting bid and Instructions to bidder

1.1. Electronic bids (e-bids) in single stage two bid system are invited by the Secretary, Cochin Port Trust, Willingdon Island, Cochin 682009 vide bid No. MSTC/TVC/COCHIN PORT TRUST/52/WILLIGDON ISLAND/21-22/24241 for allotment of Open Space B-5 at CoPT Walkway, alongside NH-966B, SER Area, Willingdon Island for a period of 5 years on license basis with payment of Onetime upfront payment as tender variable on tender-cum-auction. Bids should be submitted in accordance with the Instructions to Bidders and Conditions of license.

1.2. Bid Document can be downloaded from any of the websites www.cochinport.gov.in or www.eprocure.gov.in/cppp or <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp>, from 08.12.2021 to 14.30 hrs on 07.01.2022.

1.3. Techno-commercial bid will be opened on 07.01.2022 at 15:00 hrs.

1.4. Date & Time of opening of Price Bid of qualified Bidders and E-Auction will be announced later.

1.6. **Remittance of EMD:** EMD for each unit as given in the section 1.5 shall be remitted in either of the two methods given below:

UTR number of the transaction should be communicated to the e-mail id of the contact person of Cochin Port Trust as mentioned in Section 1.37, at least one day before the date and time of opening of e-tender. Cochin Port Trust will verify receipt of EMD as referred in the UTR number, in the Bank account mentioned in section 1.6.1. If EMD amount has not reflected in the Bank account of Cochin Port Trust, the bid will be rejected.

1.6.2. **By DD/Bankers Cheque:** Bidder has the option to remit EMD as given in section 1.5 in the form of the DD/Banker's Cheque from a Scheduled / Nationalized bank, drawn in favour of FA&CAO, Cochin Port Trust, payable at Cochin. Original DD(s) in lieu of EMD should be put into an envelope superscribed with tender number, due date, name of bidder, unit number for which the bid is submitted. The envelope containing EMD should be dropped in the tender box marked "Estate Division", placed in the reception area, in the Ground Floor of Administrative Building, Cochin Port Trust, Willingdon Island prior to the due date and time for submission of bid, failing which the bid will be rejected. EMD in the form of Cheque/ Bank Guarantee will not be accepted.

1.7. Bids without EMD(s) as stated in section 1.5 will not be accepted and will be rejected without opening the contents of the techno-commercial bid. The EMD(s) of disqualified bidders will be refunded immediately after completing technical evaluation of the tender. EMD(s) of unsuccessful bidders will be refunded after completing the E-auction of the respective plot. The EMD(s) of successful bidder will be retained at Port as security deposit for the license on remittance of the upfront payment, which will be refunded on termination/expiry of the license, complying with other conditions of the license. If the successful bidder does not pay the upfront payment, the EMD will be forfeited.

1.8. The EMD shall be forfeited under the following circumstances:

1.8.1. If the price quoted in the price bid is not above the Reserve Price for Onetime Upfront Payment for the unit.

1.8.2. In the event of the bidder withdrawing / modifying his bid before the expiry of bid validity of 90 days from due date of the tender.

1.8.3. Failure to pay Onetime Upfront Payment within the stipulated/extended time, upon award of pre-acceptance letter.

1.9. **Tender variable** is the Onetime Upfront Payment payable by the successful bidder for the property. Reserve Price of Tender Variable is stated in the price bid. Bidders are required to quote price above the Reserve Price. Any price quoted not above the Reserve Price for the property will not be considered and will be rejected. GST at prevailing rate will be charged extra. No additional rent is applicable for the license for the period of 5 years.

1.10. Bidders have to read the entire bid document carefully and should give an undertaking as per section 3 that they have accepted all terms and conditions of allotment. Undertaking as per section 3 should be signed and uploaded in the e-tender portal.

1.11. Bidder should fill-in details as given in section 4 of this document on-line, which includes activities proposed in the licensed property.

1.12. **Minimum Qualification Criteria (MQC):** Bidders must satisfy the following criteria to qualify in the bidding. Document to prove MQC should be uploaded in the portal. Bids which do not satisfy the MQC will be summarily rejected and will not be considered for further evaluation.

1.12.1. The bidder should be an individual of India or a proprietorship firm/partnership firm/ a company, registered in India. The bidder should submit proof of the same.

1.13. **Validity of Bid:** The bid shall remain valid for a period of 90 days from the date of opening of technical bid. Cochin Port Trust, for any reason, whether at its own initiative or in response to query from prospective bidders, may modify the Tender document by an amendment, at any time, 3 days prior to the due date of submission of the tender.

1.14. Details of property offered are given in section 5 of this document.

1.15. This e-bid of Cochin Port Trust is executed through the service provider M/s MSTC Ltd, 19/5&19/6,3rd Floor, Kareem Tower, Cunningham Road, Bangalore-560052.

1.16. Bidders are required to register themselves online with <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp> by following the link:- Port Lease Property→ CoPT→ Registration → Register as Bidder → Filling in details and creating own user-id and password→ Submit. The bidder shall pay Rs.1,000/- +GST to MSTC as registration charge. Validity of the registration will be one year. The bidder can extend the validity by paying the above/modified charge per year.

1.17. Bidders will receive a system generated mail confirming their registration in the mail id which the bidder has provided at the time of filling in the registration form. This e mail should be forwarded to the contact persons of MSTC mentioned in section 1.36.

- 1.18. Only after registration, bidder can submit bids electronically. Submission of Technical bid as well as Price bid has to be done by electronic bidding through the internet.
- 1.19. Bidder will receive a unique registration number and password to log-in to MSTC e-tender site. At this stage, bidders who are in possession of Digital Signature Certificate are eligible to participate in the e-auction process.
- 1.20. The bidders should have a valid digital signature certificate (at least class-II) issued by any of the valid Certifying Authorities to participate in the e-bid.
- 1.21. Bidders should make their own arrangement for bidding from a PC connected with internet. Neither CoPT nor MSTC shall be responsible for making such arrangement.
- 1.22. Both price bid & technical bid are to be submitted online at <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp>
- 1.23. Submission of on-line Bid.
- 1.23.1. Follow the links: <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp> → Port Lease Property → CoPT → Login → Click for Auctions → Stage I Bid Submission → Live Auctions → Selection of the live event → Techno Commercial and Price Bids
- 1.24. In all cases, bidders should use their own ID and Password along with Digital Signature at the time of submission of their bid.
- 1.25. All electronic bids submitted during the e-bid process shall be legally binding on the bidder.
- 1.26. **Submission of Bid:** The bidders are required to submit bid in e-bid mode only on <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp>, before the due date and time fixed for opening of techno-commercial bid. Following document should be uploaded in the tender portal.
- 1.26.1. EMD should be submitted as stated in this tender document
 - 1.26.2. Documents to prove MQC as stated in section 1.12
 - 1.26.3. Undertaking as per format given in section 3
- 1.27. Price Bid should be filled online by the bidder.
- 1.27.1. Reserve price for the property will be displayed by the system on-screen in the Price Schedule format.
 - 1.27.2. Then the bidder should quote Onetime Upfront Payment, he is willing to pay for the tendered property. The quoted amount shall be greater than the 'Reserve Price'.
 - 1.27.3. Immediately, the system will display the quoted Onetime Upfront Payment for the total area of the property, with taxes extra thereon.
- 1.28. **Opening of Techno-commercial bids:** Techno-commercial Bid will be opened at 15:00 hrs on 07.1.2022 in the e-bid portal <https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp>.
- 1.29. **Opening of Price bids:** Price bids of those bidders who satisfy MQC as per clause 1.12 will be opened subsequently.
- 1.30. **E-auction** shall be conducted after opening price bid, with highest price bid as the floor price for e-auction. Date and time of e-auction will be intimated to the qualified bidders through e-mail in advance.
- 1.30.1. During e-auction, a willing bidder shall get time to submit bid or improve the same as may be desired until the closing time.
 - 1.30.2. In case of submission of any bid up to eight minutes before closing time of e-auction, the system will allow further bid by any other technically qualified bidders for the next eight minutes from the time of submission of last online bid. This will go on till no bid is received within eight minutes of the last bid received. Once the period of eight

minutes without any bid is over, the bidding will automatically close and no further bidding will be allowed by the system.

1.31. In case a bidder does not participate in the e- auction, his only bid will be that given in the Price bid.

1.32. E-auction will not be conducted in case only one valid bid is received for the plot.

1.33. The bidder who has quoted the highest bid after considering the price bid and that obtained through e-auction amongst all the bidders shall be treated as the successful bidder for each property subject to clause 3.7.

1.34. All taxes, as may be applicable from time to time shall be payable extra above the final bid amount.

1.35. Cochin Port will not take responsibility for any technical difficulties encountered by the bidder in participating in the e-bid.

2. General conditions of license

- 2.1. Cochin Port Trust (CoPT) has developed the “CoPT Avenue Walkway” (herein after referred as the Walkway” which includes the parking area alongside of the road, open area at both end of the walkway and the reclamation wall, alongside the backwater) of 2 km length, between Mattancherry BOT Bridge and Kannanghat Bridge by the side of NH-966B at South End Reclamation Area of W/Island. The “Walkway has been developed as a promenade facing backwaters, where the public may take leisurely walks and strolls for pleasure. The facility is to be maintained as a place of interest and popular relaxation spot with a jogging track, park, children play area, food outlets and facilities for water sports benefitting the public/tourists.
- 2.2. In order to cater various services to the users of the walkway, Cochin Port has allotted 4 open spaces of area 30 Sq m each at various locations in the Walkway for Tourism related activities, Sports/recreational activities, Art & culture related activities, operating kiosks/sales & service outlets, food and beverage vending. Now Cochin Port intends to allot one more open space of 30 Sq m area in the east side of the walkway as marked as ‘B-5’ in the sketch attached. The area proposed for allotment is also intended for Tourism related activities, Sports/recreational activities, Art & culture related activities, operating kiosks/sales & service outlets, food and beverage vending. The successful bidder can remove the trees planted in the earmarked area B-5 or replant to other suitable area in the walkway. If the trees are removed, the successful bidder shall plant similar trees in the nearby suitable area.
- 2.3. The allotment will be for a period of 5 years.
- 2.4. The successful bidders can erect temporary structures in the allotted area for the purpose for which the space is allotted. Maximum permitted height is 6 m. The structure shall be constructed complying with the height restriction due to proximity of Naval Runway for which the successful bidder can approach Naval Authority to obtain NOC (height clearance).
- 2.5. The structure shall be architecturally designed and should have an aesthetic look. The perspective drawings and plans should be submitted to the Chief Engineer, CoPT for prior approval.
- 2.6. Cooking is not permitted in the licensed area, except for tea/coffee/snacks. However, cooked food can be served in the area.
- 2.7. The licensee should make his own arrangements to remove the waste/garbage generated from his premises.
- 2.8. Total licensed spaces in the walkway will not be limited to 5 as stated at para 2.2. Cochin Port may allot more open spaces in the walkway in future as per demand for various activities. The open spaces available at both end of the walkway may also be allotted later for setting up of Food Courts and other activities. Water area adjacent to the walkway will be allotted for setting up of Floating Restaurants and Water Sports related activities.
- 2.9. Applicable acts and directives: This license shall be governed by the provisions of the Major Port Authorities Act, 1921, Indian Ports Act, 1908, Policy Guidelines for Land Management for Major Ports and all directives issued by the Government of India from time to time. It shall be binding upon the licensee to comply with all such directives issued by the Government of India and communicated by the Licensor.
- 2.10. Site inspection: It would be deemed that prior to submission of bid, the bidder has made a complete and careful study of the existing conditions including but not limited

- to (a) the site conditions; (b) condition of building/structure (c) condition of the access road & surroundings and has assessed the extent of the work/construction requirements to utilize the allotted space for utilization. It is also deemed that they are fully aware of all the applicable laws and applicable permits pertaining to the purpose for which they intend to use the premises. The Port Trust shall not be liable for any mistake or error or neglect by the bidder in respect of the above. The tendered asset is offered on as-is where-is basis. The bidder is expected to examine carefully the contents of the bid documents, including but not limited to the terms and conditions in the format of license deed given at section 7.
- 2.11. Provisional allotment order: On acceptance of bid by Cochin Port Trust, a Pre-acceptance letter will be issued to the successful bidder, for remitting the Onetime Upfront Payment, offered by the successful bidder through the tender cum auction.
 - 2.12. Onetime Upfront Payment: Successful bidder has to pay the Onetime Upfront Payment as quoted in the tender plus GST (presently 18%), within two months of date of receipt of the Pre-acceptance letter by the successful bidder.
 - 2.13. Security Deposit (SD): The EMD submitted by the successful bidder will be retained at Port as non-interest-bearing refundable security deposit for the duration of the license. As and when any deduction is made from the security deposit, the licensee shall within a period of one month, deposit with the CoPT as additional security deposit such further amounts as will make the total security deposit equal to Rs.56,000. The security deposit so paid shall be refundable without interest, after adjustment of any dues or other amounts due to the Licensor and/or damages to the Premises, at the time of handing over vacant possession of the licensed premises on the expiry or termination of the license.
 - 2.14. Mode of Payment: All payments to Cochin Port Trust shall be made through e-payment or by Demand Draft drawn in favour of the Financial Advisor & Chief Accounts Officer, Cochin Port Trust, from State Bank of India or any of its subsidiaries/ Nationalized Banks/ Scheduled Banks.
 - 2.15. Bank Details of Cochin Port Trust for e-payment

 - 2.16. Allotment order: On receipt of the Onetime Upfront Payment, Cochin Port Trust will issue allotment order to the successful bidder. On receipt of the allotment order, the Successful bidder shall submit the architectural design followed by detailed engineering design of the temporary structure proposed to be installed in the allotted area to the Estate division for approval. Also, the licensee can apply for electricity and water connection to the respective offices of Cochin Port Trust. In the meantime, the successful bidder can apply for height clearance of Navy. On receipt of applical approvals, the successful bidder can commence installation of the temporary structure in the allotted area. The successful bidder shall complete the above activities within 6 months from the date receipt of the allotment order.
 - 2.17. Taking over of property and commencement of license: Within 6 months from the date of receipt of the allotment order, the successful bidder shall take over the land. The 5 year license period will commence from the date of takeover of the property or from the day completing 6th month from the date of issue of the allotment order, whichever is earlier. Failure to take over the licensed property on or before the due date will not entitle the licensee for commencing the license period. Sketch and area

given is approximate and there may be marginal variations in the extent of area and locations.

- 2.18. Execution of deed: The licensee shall execute and get registered a license deed within six (6) months from the date of commencement of the license. Cochin Port Trust shall be entitled to cancel the allotment if the licensee does not execute the license deed within time. However, delays beyond the control of the lessee in execution and registration of the lease deed shall be excluded from the above six (6) months.
- 2.19. The successful bidder can remove/re-locate minimum number of RCC Bollards laid in the berm of the road for parking of customers vehicles, with the permission of CoPT.
- 2.20. At the time of handing over, to suit the site condition or to facilitate construction, if any additional area is required, same shall be permitted on remittance of upfront payment on pro-rata basis.
- 2.21. Scope of license: What is tendered and allotted under this tender is only a license to use the property and the licensee does not have the right to possess the property to the exclusion of Cochin Port Trust. The property is only temporarily allotted on license basis for the period stated in the final allotment order, starting from the date as stated in section 2.17 of this document. The license is not automatically renewable. Any further extension, if at all, is at the sole discretion of the Port Administration. Allotment of property does not in any manner confer on the licensee any right whatsoever over continued occupation / stay in the licensed property. Cochin Port Trust reserves the right to terminate the license at any time after giving one month's notice for vacating the property.
- 2.22. License fee payable: Since the entire license fee for the 5 year license period is collected as onetime upfront payment, no additional license fee is payable for the license period of 5 years.
- 2.23. Electrical energy charges: During the term of tenancy the licensee shall pay electrical energy charges consumed as shown in the Meter readings and also such rent as may be stipulated for the meter installation at the rates notified by the Port Trust, from time to time. The charges should be paid every month within 7 days on demand, failing which the connection will be disconnected on the 8th day without any notice. The restoration of electricity connection thereafter shall be done only after payment of restoration charges or such other charges as communicated by the Dy. Chief Mechanical Engineer (Electrical).
- 2.24. Water Charges: During the term of tenancy the licensee shall pay for fresh water used or consumed as shown in the Meter readings at the rates, notified by the Port Trust, from time to time. The charges should be paid every month within 10 days on demand failing which the connection will be disconnected on the 11th day without any notice.
- 2.25. Payment of taxes, charges, and assessments: The licensee shall from time to time and at all times during the term of license pay and discharge all rates, taxes, charges, and assessments of every description now subsisting, including arrears if any, accrued or due after the date of commencement of the term of license, or which may at any time hereafter during the said term, be imposed, charged or assessed upon the licensed property, whether it be payable by the licensor or Cochin Port Trust.
- 2.26. Penal Interest for delayed payment: The Licensee shall be bound to pay interest on all overdue payments from the date when the same becomes due, at the rate as

specified in the Scale of Rates for the time being in force and as revised from time to time, it being made clear that the liability for payment of interest shall not affect the other rights accruing to Cochin Port Trust on account of such defaults on the part of the Licensee.

- 2.27. Right to enter the licensed property: The Authorized officials of the Port with or without workmen or others will have the liberty to enter the licensed property at all times to view the conditions and state thereof or for any other reason.
- 2.28. Disconnection of utility services: Cochin Port Trust reserves the right to disconnect electricity & water connection and stop all port related services to the Licensee in the event of non-payment of any of the dues as stated above and the licensee shall be solely responsible for any loss or damage arising out of this. Port will not be held liable for any loss or damage arising out of the disconnection of electricity and water connection on account of non-remittance of dues within the stipulated time.
- 2.29. Utilisation and up keeping of licensed property:
 - 2.29.1. The licensee shall undertake the required repairs, maintenance, furnishing, flooring, painting, etc. at their cost at the initial time as well as time to time to use the property. The Licensee shall use the licensed property only for the purpose(s) for which the licensed property has been allotted/ licensed, unless otherwise approved by Cochin Port Trust. If it is noticed that the Building / open space is being used for the purposes other than what has been specifically permitted then the license shall be terminated without further notice at the risk and cost of the licensee. Permanent construction shall not be allowed in the licensed open property.
 - 2.29.2. The licensee shall not make any unnecessary excavation or remove or appropriate any minerals, mineral substances of any description, sand or clay, from the licensed property. Any such materials obtained from the licensed property should be placed or disposed of as directed by the Chief Engineer, Cochin Port Trust or his/ authorized representative.
 - 2.29.3. The licensee should obtain prior approval of the Chief Engineer before making any constructions / alterations / modifications / additions to the structures / buildings / space so licensed. All plans for the development of licensed property shall be got approved by the Chief Engineer, Cochin Port Trust. Any constructions / alterations / modifications / additions to the structures / buildings / space done without the prior approval of the Chief Engineer will be treated as violation of the license condition and the license would be liable to be terminated without notice, at the risk and cost of the licensee. The plan should also be got approved by the Local Authority concerned before commencement of any work.
 - 2.29.4. The licensee shall have quiet and peaceful use of the licensed property, subject to their fulfilling the terms and conditions contained herein, however without in any matter compromising the right of the Cochin Port Trust to enter the property.
 - 2.29.5. The licensee shall utilize the maximum permissible area of the Licensed property for purpose for which it is allotted. If the licensee does not or is not able to utilize the entire licensed property licensed to him, the portion of the licensed property not required by him should be vacated without any liability for payment of compensation. If the licensee fails to adhere to the same or the licensee does not vacate the unutilized portion of the licensed property, Cochin Port Trust shall have the right to takeover complete possession without any claim for compensation whatsoever, the whole or part of the portion of the licensed

- property left unutilized and use the same in any manner deemed expedient by Cochin Port Trust.
- 2.29.6. The Licensee shall not at any time without the previous consent in writing of the Cochin Port Trust erect or suffer to be erected on the licensed property any structure(s) other than those approved by Cochin Port Trust or make any alteration in the plan or elevation of the said buildings or use the licensed property for any purpose other than that approved by Cochin Port Trust.
- 2.29.7. The licensee shall obtain all statutory and mandatory clearances as may be required under law from appropriate authorities, before undertaking any activity and from time to time thereafter and also comply with all the norms as laid down by these statutory authorities.
- 2.29.8. It shall be the responsibility of the licensee to keep the surroundings adjoining their property clean and devoid of any wild growth or waste. The Licensee shall at all times during the subsistence of the license maintain the Licensed property in good sanitary condition and repair and keep the building(s)/structure(s) in the Licensed property in good and tenantable condition. If the Licensee fails to do so, Cochin Port Trust may, if necessary, arrange for execution of necessary works to maintain the licensed property and shall be entitled to recover the costs incurred for the execution of such works from the licensee.
- 2.29.9. The licensee shall keep the Port informed when any toxic or hazardous cargo is warehoused in the licensed property. Such cargo shall be warehoused only after obtaining all statutory sanctions and producing copies of the same before the CE/Secretary.
- 2.30. Indemnifying Cochin Port Trust: Cochin Port Trust shall not be responsible to the licensee or any other person(s) for any loss or damage or injury to life or property arising directly or indirectly from the use of the licensed property and the activities the licensee is engaged in on the licensed property during the period of License. The licensee shall also indemnify Cochin Port Trust against all loss or damage or injury to life or property of anyone, including third parties or claims and costs thereof arising directly or indirectly from the use of the licensed property by the licensee and the activities the licensee is engaged in the licensed property, due to any defect or any act or default of any employees of the port or any other person during the period of license.
- 2.31. Applicable laws: License shall be governed by provisions of the Major Port Authorities Act, 2021, Indian Ports Act, 1908, Policy Guidelines for Land Management for Major Ports and all directives issued by the Government of India from time to time. It shall be binding upon the Licensee to comply with all such directives issued by the Government of India and communicated by Cochin Port Trust to the licensee.
- 2.32. Utility services: If, on request in writing by the licensee, Cochin Port Trust removes/relays/re-routes or causes removal/relay/re-routing of any utility services such as underground or overhead electric lines, telegraphic or telephonic lines, water pipelines, drains etc., from the licensed property, the licensee shall pay the Cochin Port Trust the cost of such removal within fourteen days from the date on which demand in writing for such cost is served on the licensee. 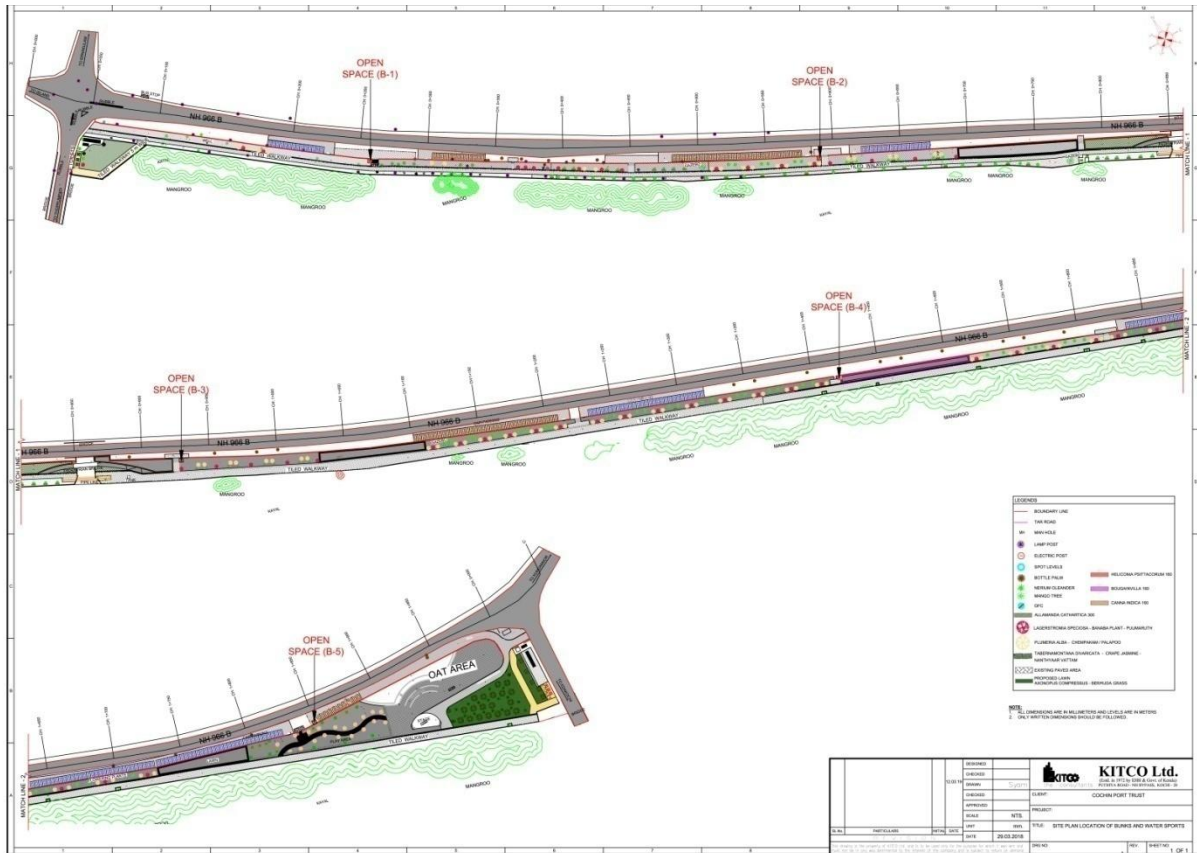

THIS DEED OF LICENSE, made the day of Two thousand and BETWEEN THE BOARD OF TRUSTEES OF THE PORT OF COCHIN, a Body corporate under the Major Port Trusts Act, 1963 having its office at W/Island, Cochin-9 represented by its(hereinafter called "the LICENSOR") of the one part;AND..... (hereinafter called "the LICENSEE") of the other part:

WHEREAS pursuant to the decision to allot on nomination basis or Notice Inviting Tender issued by the Licensor, the Tender submitted by the Licensee has been accepted by the Licensor and the Licensor has agreed to allot to the Licensee by way of License the Open Space on the terms and conditions herein contained.

NOW THEREFORE THIS DEED WITNESSETH that in consideration of the upfront payment paid as stated hereunder and other terms and conditions on the part of the Licensee to be observed, the Licensor does hereby grant to the Licensee, License of land containing by admeasurements 30 Sq m or thereabout situated on Willingdon Island which part of premises is more particularly described hereunder written and for greater clearness, delineated with the measurement thereof in the plan annexed hereto (hereinafter referred to as the "licensed premises") TO HOLD the same for a term of Five (5) years from the day of(i.e., the date of execution of the deed) to the day of (month & year) , for the purpose(s) it is allotted ie. subject to the following conditions:-

- 1.1. The Licensee has paid to the Licensor as one time upfront payment for the License of the licensed premises an amount of Rs.....(Rupees.....only) plus Service Tax / GST.
