Sub:-Filling up the post of Chief Medical Officer in Cochin Port Trust.

The post of Chief Medical Officer in the scale of pay of Rs.100000-260000/-in Cochin Port Trust will fall vacant w.e.f. 01-04-2022.

- 2. Applications are invited for filling up the post of Chief Medical Officer in the scale of pay of Rs.100000-260000/- in Cochin Port Trust by absorption through composite method from the Officers holding posts in the Scale of Pay of Rs.80000-220000 with three years regular service in the grade in the Medical Department of a Major Port Trust. The copy of Recruitment Rule is enclosed as **Annexure** –I.
- 3. The requisite educational & other qualifications prescribed as per RR for absorption through composite method, are as under:-

1. MBBS Degree from a recognized University

- 2. A post graduate (PG) Medical Degree or PG Medical Diploma in the specified specialty from a recognized University
- 4. The selection is by merit for which the bench mark in overall grading in the Annual Confidential Reports shall not be below "Very Good".
- 5. The Eligible and willing Officers who satisfy the provisions of Recruitment Rule for the post of Chief Medical Officer shall apply through the "Online Application Portal (OAP)" of the Ministry of Ports, Shipping & Waterways https://onlinevacancy.shipmin.nic.in). The applicant has to register in the Online Application Portal. No application other than OAP shall be accepted.
- 6. The candidate shall submit the print out of online application submitted via OAP and the Administrative Ports are requested to forward the application through proper channel along with the following documents in an envelope, superscribing 'Application for the post of Chief Medical Officer in Cochin Port Trust on absorption basis', to the Secretary, Cochin Port Trust, Willingdon Island, Cochin-682 009 so as to reach on or before 10.03.2022.
 - 1. Attested copies of Annual Performance Appraisal Reports (APARs/ACRs) of the applicant for the last 5 years (01.04.2016 to 31.03.2021) (Attested by an Officer not below the rank of Dy. HOD on each page).

2. A statement showing year-wise availability of APARs/ ACRs and grading duly signed by the Competent Authority. If the APAR for a particular period during the last 5 years is

not available, "No Report Certificate" may be furnished alongwith the APARs of preceding years.

3. Attested copies of all Certificates and proof of educational qualification, present and past

work experience in the respective post and pay scale.

4. No-Objection certificate of the concerned Port Trust.

5. An undertaking of the applicant not to withdraw his/her candidature, if selected. Officials, who withdraws his/her candidature for the Post after his/her selection by the Services Selection Committee, will be liable for debarment from future selection to HOD level posts in all Major Port Trusts for a period of two years.

6. Certificate by Head of office of the applicant as per Annexure-II.

7. The vigilance status of the candidates may be furnished in the prescribed Proforma duly signed by the CVO of the concerned Port alongwith the application (Annexure-III). If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application.

8. Two recent passport size photographs in a sealed envelope.

9. The details of the applicants, length of service in feeder grade posts with pay scales, final APAR gradings and eligibility position may clearly be indicated in the proposal.

10. The Veracity of the University Certificates produced by the applicants and the recognition of the degree obtained by the applicant shall be ensured and certified by the concerned officer of the Port.

The crucial date for eligibility criteria will be 01.04.2022 in terms of Ministry of Ports, 26.09.2019. No.I-26/25/2013-PE-I dated Waterways Circular In case of receipt of advance copy of application in respect of any applicant by the Port, Shipping his/her candidature will not be considered if application is not received through proper channel within 15 days of last date of receipt of applications, mentioned at Sl. No. 6 above in this regard. 9. Incomplete application or application which has been submitted without the stated procedure

or received after due date will not be considered.
