Electronic bids (e-bids) in single stage two bid system (Technical Bid and Price Bid) are invited by the Secretary, Cochin Port Authority, Willingdon Island, Cochin 682009 vide bid No. MSTC/TVC/COCHIN PORT TRUST/11/WILLIGDON ISLAND/23-24/15287 for lease of 2 ha (4.942 acre) of land in Puthuvypeen Non-SEZ Area for a period of 30 years with Annual Lease Rent as tender variable on Tender-cum-Auction. 4. The bids should be submitted in electronic form only through e-bid portal https://www.mstcecommerce.com/auctionhome/kopt/indexcpt.jsp. The bidders shall upload soft copy of all the required documents in the e-bid portal.

5. Earnest Money Deposit (EMD): EMD as at Section 0 above (derived at 10% of the annual lease rent as per the SoR for the plot, for vacant plots; and at 10% of the annual lease rent as per the SoR for the plot plus 10% of the value of the existing building/structure, for plots with building/structure) should be remitted through RTGS/NEFT or in the form of Banker's Cheque or DD issued by Nationalized/ Scheduled Banks, drawn in favour of FA & CAO, Cochin Port Authority, payable at Cochin.
