
Filing an appeal under Right to Information Act 2005 against the Public Information Officer & Chief Account Officer for not providing the information asked for.



I have considered your RTI appeal dated 19.09.2022.



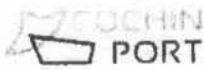
