The Ministry of Shipping, Gov. of India, vide No. SW-15011/2/2016-MG dated 21.05.2018 has ordered that Section 407 (1) of the Merchant Shipping Act, 1958 shall not apply to foreign flag ships engaged for the Coasting Trade of India, for transportation of EXIM laden containers for transshipment, and for transportation of empty containers, subject to certain specified conditions. The Ministry of Shipping has also ordered vide No. SW-14020/5/2009-MG/SA (Vol.9) dated 22.05.2018 that Section 407 (1) of the Merchant Shipping Act, 1958 shall not apply to foreign flag ships engaged in the Coasting Trade of India for carriage of a specified list of Agricultural, Fisheries, Animal Husbandry and Horticultural commodities, subject to specified conditions.
