1. Kindly see Chairman's noting dated 15.06.2019 at N/42, wherein, in view of Ministry's latest directions/ orders with regard to filling up of posts, the Chairman has directed to seek special permission from the Ministry to issue appointment orders to the selected candidates for the post Asst. Exe. Engineer (Mechl.) under direct recruitment. Chairman has also directed the same in File No. 47 regarding filling up of 4 posts of Asst.Exe. Engineer (Civil) under Direct Recruitment. The same is also applicable in the case of filling up 2 posts of Asst. Exe. Engineer (Ele.) under Direct Recruitment.

2. In this regard, it is informed that as per the recent directions from the Ministry of Shipping vide letter No.A-12033/12/2017-PE-II dated 22.05.2019 (<u>C-83</u>) for appointment of Class-I entry level posts including Asst. Exe. Engineer (Civil/Mechl,/Electrical), new procedure to be adopted under the provision of Regulation 11 of respective RSP Regulation and all Major Ports are to make suitable amendments in the RSP Regulations to this effect. Further, at Para 5 of the letter, Ministry has stated that the new guidelines will come into effect from the date of issue of the order and **no selection to be done for the aforesaid Class-I posts except under provision in the new procedure**. Accordingly, the new guidelines will be applicable for the selection to the entry level Class-I posts w.e.f. 22.05.2019. However, Cochin Port Trust had made the selection of candidates for the one posts of Asst.Exe. Engineer (Mechl.), 4 posts Asst.Exe. Engineer (Civil) and 2 post of Asst. Exe. Engineer (Ele.), prior to 22.05.2019, but, the issue of appointment orders to the selected candidates were kept pending due to the Model Code of Conduct on account of Parliamentary Election. Hence, the Ministry's direction cited above is not applicable in the case of filling up the above posts under direct recruitment, as the selection process had been made prior to 22.05.2019.

3. 


