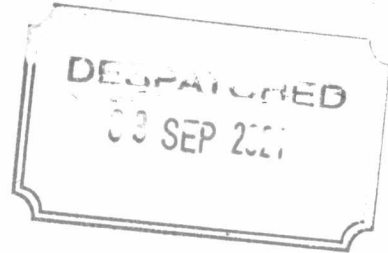

Reference to the query by Chairman, dated 27.07.2011


18. The subject was discussed further in a Meeting held on 28.07.2011 wherein, the Chairman, Dy. Chairman, Secretary and FA & CAO were present. Based on the discussions, the following facts are submitted for kind consideration of the chairman for taking a final decision on the matter.

19. Initially, ten post of OCIOA was created on a regular basis. Subsequently in the year, 1998 six posts of OCIOA and four posts of Sr. OCIOA were created. The additional six posts of OCIOA were filled up on a regular basis by re-deployment from different categories following a process of selection. Circular was issued inviting applications to these posts from eligible regular employees. In the Circular, it was made clear that the selected candidates will have to sever the relationship with the parent cadre and they have to exercise option for fixation as the post was filled up on a regular basis. As such, there is no addition in the total strength of employees and hence reduction of strength in the respective parent cadre may be effected to resolve the issue so that the total number remains the same. As such, four post of Sr. OCIOAs and one additional post of OCIOA will be treated as re-deployed effecting corresponding reduction in the strength of their parent cadres.
