Note to the Chairman

Sub: Reversion of employees of EDP Division consequent on abolition of project posts on 1st April 2011.

- 1. Recently the modality unions of the Port, CPSA and CPEO have issued strike notices under ID act citing various reasons including the reversion of personnel in EDP Division consequent on abolition of project posts created for e-Port and other project those posts continued after MIS project. According to them, this reversion has been done without extending natural justice in respect of employees who were holding the posts for the last 12 years.
- 2. To discuss the various issues mentioned in the strike notice, three discussions were held with the modality unions, but the issue relating to reversion of personnel in EDP Division is remaining unsettled. In the second meeting, Chairman assured that a committee comprising Dy.Chairman, Secretary and FA & CAO would look into the issues relating to the EDP Division and try to find a solution for the grievances of the personnel who were reverted.
- 3. The Port had commenced a major computerization initiative in the year 1997, conceiving the MIS project. A number of posts were created for execution of this project vide Board Reso.No.108 dated 24th Oct 1997. Subsequently, vide Board Reso.No. 108 of 10-12-1998, four posts of Sr.CCIOA were created.
- 4. The posts of Sr.OCIOA were filled up by promotion from OCIOA and the employees thus promoted were given option to exercise as if they are regularly promoted. In the subsequent years, in the Schedule of Employees published by the Port, these posts were shown as permanent posts. These posts were continued till March 2011, although a number of incumbents were considered for higher posts created for e- Port project during
- S. The Port management has decided to abolish all the project posts except those created under capital dredging and deposit works w.e.f. 1st April 2011 and accordingly orders were issued and the incumbents were reverted to their substantive position. Thus

two persons who were holding the post of Sr.Supervisor were reverted to the post of OCIOA, one Sr.OCIOA was reverted to the post of OCIOA.

Sr.OCIOA was later promoted as Programmer and continued in that post till 31-03-2011. He was also reverted to the post of OCIOA. It may be noted that cadre restructuring orders of the Port were notified in the Official Gazette of Govt of India on 28-10-2010. As per the notification, an additional post of Programmer was created in the EDP Division, apart from the existing strength of two Programmers. This additional post was not given to Shri.Felix w.e.f. 1-04-2011 who is holding the project post of Programmer till 31-03-2011, though he was fully eligible for it. When the said employee was reverted to the post of OCIOA, there is a dip of Rs.6750/- in his emoluments. Had he begiven the post of Programmer prior to 1-04-2011, this could have been avoided.

7. The modality unions have been urging the Port management to redress these grievances immediately. In view of the position, considering the issues in its entirety, it is proposed;-

- to treat these four posts of Sr.OCIOA as permanent posts and the reversion to the respective employees should be done to the posts of Sr.OCIOA, rather than to OCIOA.
- to consider Shri.Felix Joseph against the newly created post of Programmer, w.e.f. 1st April 2011 and his reversion to the post of OCIOA w.e.f. 1-04-2011 may be cancelled.
- 3) to fill up the vacant posts of Sr.OCIOA from OCIOAs.
