



15 Observation of the DPC

DPC observed that :-
1.As per RR, the selection to 20% quota will be based on seniority among candidates declared qualified in the written qualifying examination.
2.Circular No.A10/1306/2021/S dt.14.11.2022 **Appendix-V** was issued inviting applications for filling up two vacancies of 20% quota of the year 2021 & 2022 in Manager/Dy.CA(Jr) cadre from graduates holding the post of Sr.Accountant/Sr.O.C.I.O.A/Accountant through written qualifying examination. In response 21 candidates applied for the post.
3.The Written qualifying examination was conducted by Indian Maritime University in the conference hall of Administrative building on 31.07.2023. Out of Twenty one candidates applied for the post, only 14 candidates appeared for the examination. Attendance sheet attached as **Appendix-VI**.
4.Out of the 14 candidates attended the examination, four candidates has secured more than 60% marks and hence declared qualified in the written qualifying examination and placed in the zone of consideration in the order of seniority and are eligible in all respect as per RR. Marklist attached as **Appendix-VII**.
5.The Competent Authority, has given approval to enlist all candidates qualified in the written qualifying examination, in a panel, in the order of seniority, so that future vacancies earmarked for 20% quota can be directly filled up with the approval of the Competent Authority from panel candidates. Such panel may be for initial one year and if required further extension for another 6 months as per Rule (**Appendix-VIII**).
6.As per Dy. Chairperson's Note dated 01.03.2023 (**Appendix-IX**) up on DoPT's O.M. dated 12.04.2022, the promotion order shall be granted subject to further orders that may be passed by the Supreme Court of India in Jarnail Singh's Case (Civil Appeal No.629 of 2022) and connected batch of cases. Further, promotion shall be subject to the further orders of Hon'ble High Court of Kerala in W.P.(C) No.13300/2021.

16. Recommendations of the DPC

The DPC considered all the relevant factors and recommended the following candidates for promotion to the existing vacancies in the post of Manager/Dy.Chief Accountant (Jr.) in the Scale of Pay of Rs.36500-88700 under 20% quota:-
1.Sri.SunilKumar.M.R, S.No.12021, Sr.Accountant, GAD
2.Sri.Paul Joseph, S.No.15409, Sr.Accountant, Traffic Dept.
The Committee also recommended to keep the following qualified candidates in the panel for a period of one year, in the order of following seniority, for considering against anticipated/unforeseen UR vacancies that may arise in the Manager/Dy.Chief Accountant (Jr) against 20% quota in case the recommended candidates do not join.
