84. Read Chairman's Note dated 14-8-13 regarding enhancing the ceiling limit of medical facilities to the dependents of Cochin Port Employees.
85. While on the subject Shri Mohammed Haneef stated that commensurate with the present minimum pension being received by the Port pensioners, the ceiling should be enhanced to Rs.3,900/- instead of Rs.3,500/- proposed.
86. Shri C.D. Nandakumar endorsed the above views.
87. After discussions, the Board resolved to fix Rs.3,900/- (plus DR on Rs.3,900/-) as the upper income limit for the dependents of Cochin Port Trust Employees for availing medical benefits.
