विषय/Sub: Rationalisation of Tariff for Cruise Vessels in India.

The Ministry of Shipping to promote the Cruise Shipping in India have rationalised the tariff for Cruise Vessels vide its letter No.SW-15011/2/2016-MG dated 03rd November, 2017 in which Ministry has directed to collect the Composite Port Charges for Cruise Vessels at \$0.35 per GRT for the first 12 hours. The Port will not charge any other rate like berth hire, Port dues, Pilotage, and Passenger fee for the first 12 hours. Beyond 12 hours, Port will collect a Berth hire of \$0.0292 per GRT per hour. The above rationalised tariff will be made effective from 03.11.2017 on a trial basis for a period of three years. The levy of Security Charges will be continued as per the existing Scale of Rate of the Cochin Port Trust.

The Board of Trustees, vide Resolution No.62(Agenda Item No.D2) dated 26.05.2017 resolve to approve wavier of Waterfront Royalty on LNG reloaded at the LNG Terminal, in line with the Concession Agreement that prescribes the levy only for LNG unloaded, and instead levy a nominal Wharfage of Rs.1/- per MT on the quantity of LNG reloaded, subject to the condition that the same should not be quoted as a precedent by the PLL.

CIRCULAR

Sub: Regulation of Port Dues and other charges from the Vessels of Republic of Bangladesh as per Standard Operating Procedure (SOP)/Coastal Agreement between India and the Republic of Bangladesh.

As per the direction of the Ministry of Shipping, TAMP has notified to incorporate the following provision in the Scale of Rates General Terms & Conditions Clause 1.2. (ii) B, as under (d) vide Gazette Notification No.467 dated 27.12.2016.

(a) As per Clause 6 of the Standard Operating Procedure (SOP) for operation of Indo-Bangladesh Coastal Shipping Agreement (given below), the vessels entering into India from Bangladesh under the Coastal Shipping Agreement between India and Bangladesh are not to be treated as foreign going (FG) vessels.

(b) Port and other charges

(i) Port dues to be levied by the Major Port Trust on the entry of vessels of the Republic of Bangladesh into India under the Coastal Shipping Agreement between the two countries and engaged in inter country trade, will be treated as domestic vessel engaged in coastal shipping and not as Foreign Going (FG) vessels.

(ii) The Major Port Trust shall also on the vessels of the Republic of Bangladesh levy charges for conservancy, Pilotage and other Specific services at par with those

charged from the coastal vessels. The charges will be determined with reference to cargo carrying capacity of the vessels, as applicable to coastal vessel engaged in coastal shipping.”

C I R C U L A R

Sub: - Waiver of 'Shifting' (Pilotage) and Berth hire charges in respect of barges engaged by various oil companies for supply of bunkers and fresh water at anchorage of Cochin Port- reg.

The Board of Trustees of Cochin Port, in their meeting held on 05/02/2015, resolved, vide Agenda Item No. D-13 to approve for extending the following concessions to all the barges engaged in bunkering operations presently and for new barges which may be chartered/owned by oil companies in the next **two years till 31st December, 2017**.

- a) Waiver of 'Shifting' (Pilotage) charges for the barges registered under IV Act, MS Act or RSV type IV; and
- b) Waiver of berth hire charges for the barges registered under RSV Type IV, MS Act during monsoon period i.e from June to September.

The above concessions will also apply for the barges engaged in supply of fresh water at outer anchorage.
