Sub: Rebates in Vessel Related Charges for Container Vessel Services at ICTT

The Board of Trustees of Cochin Port Trust vide its Meeting dated 23rd October, 2019 has resolved to approve the following rebate structure on Vessel Related Charges for a period of three years from 01.11.2019 to 31.10.2022 for Mainline Services, and for a period of one year from 01.11.2019 to 31.10.2020 for Mainline Container Vessel Calls (ad hoc) and Non-Mainline (Feeder) Services at ICTT

i) Rebate on VRC for Mainline Container Vessel Services

It is also resolved to neutralize the hike expected on VRC, other than periodical indexations, in the revised SoR of CoPT applicable with effect from 29.11.2019, for foreign ships to which rebates are allowed under the present scheme, through appropriate discounts.
